following laws including, but not limited to Natural Law, the International human subject protections contained in the Nuremberg Code, Nuremberg Treaty, the Helsinki Declaration, Article Seven of the International Convention on Civil and Political Rights (ICCPR), guidelines by the Council for International Organization of Medical Services (CIOMS), the International Conference on Harmonization of Technical Requirements for Registration of Pharmaceuticals for Human Use Good Clinical Practices (ICH/GCP), the recently revised FDA's "Good Clinical Practices" (GCP) guidelines for foreign clinical trials and certain World Health Organization (WHO) guidelines, the Alien Tort Statute (ATS), 28 U.S.C. § 1350 and Title 45 Public Welfare Part 46 Protection of Human Subjects (45 CFR 46).

3. Disclaimer Statement #3: "Human Subjects" Have Not Entered into Any Contracts & We are "Disclaiming" Ourselves from All Relationships Pertaining to Any Research Projects and/or Experiments Immediately

We have not entered into any contract (open ended, lifetime, generational and/or with our minors) voluntarily nor of free will with the researchers to be in any human subject research or medical experiment in our conscious state in America & Internationally. We have not entered any contract voluntarily nor of free will, which continues forever for generations by moving our family members from one human subject research and/or experiment to another for years, decades, and/or centuries without any possibility of being terminated or canceled. There has been **no** mutual agreement to the terms and conditions of the contract. A "party" to a contract cannot be a minor. A "party" to a contract cannot be in a state of unconsciousness, nor in a state of incompetence. Contract entered into by such a party is a Nullity, Ab Initio. According to Black's Law dictionary, disclaimer means,

"The repudiation or renunciation of a right or claim vested in a person or which he had formerly alleged to be his. The refusal, waiver, or denial of an estate or right offered to a person. The disavowal, denial, or renunciation of an Interest, right, or property imputed to a person or alleged to be his."

We want all agents, city/county/state & federal employees, city/county/ state/& federal officials, employees, officers, informers (in fact not presumption), contractors, sub-contractors, members, and representatives to enforce our right that we are "disclaiming" ourselves from all relationships pertaining to any human subject research projects and/or medical experiments immediately. It is null & void effective immediately.

The U.S. Federal Government has failed to do three things:

- i. The NSA's PRISM Research Project violates the United States Constitution. The NSA employees and contractors have failed to uphold their solemn oath to the United States Constitution by conducting such a research project.

- iii. NSA has failed to tell the involuntary or unwitting "human subjects" that they can **opt-out** of the NSA's PRISM Research Project, as per the United States Common Rule, research ethics, and International laws. The "human subjects" can "opt-out" from being experimented on without his/her informed consent or knowledge by **all** agents, city/county/state & federal employees, city/county/state/& federal officials, employees, officers, informers (in fact not presumption), contractors, sub-contractors, members, and representatives.

Enough is Enough!

For the past 4 years, Former Government Electronics Engineer turned Activist Letitia Peters states, "We have enough and we want all unconstitutional activities to cease and desist TODAY and we want out of these so called unethical, unconstitutional human subject research projects, which are really murder for hire, slavery, genocide projects with Nazism and KKK propagandas now BEFORE the New Year. Edward Snowden is absolutely right. I have done the extensive research, which can corroborate what Edward Snowden has said. I have to finish typing the final research, but due to the Federal Government telling these

employees to sell me contaminated and tampered laptops, flash drives, cameras and mobile broadband. Now, I have mold coming out of my body. How is that possible in only two weeks? Am I being afflicted with mycotoxins, which is a biological weapon? What is going through my hands when I pick-up the mail or buy newspapers, which is undetected by the naked eye? Within minutes, my body starts responding to whatever was sprayed on the mail or newspaper.

These people have the spirits of racism, hatred, greed, untouchable, psychopath, sociopath, power, pride, arrogance, love of money, unbelieving, hatred towards Jesus/Yeshua, witchcraft, occult, and lying spirit will NEVER STOP so it is time to stop them based on the court ruling and the release of the information by Edward Snowden.

I have reached my breaking point and I received confirmation from Apostle Esther that my enemies will be destroyed. I release and loose God's judgment on everyone who is an enemy to the involuntary or unwitting human subjects in America and International in Jesus/Yeshua's name. It is finished in Jesus'/Yeshua's name! Checkmate.

Since my neighbors who have committed heinous crimes for the past 4 years against me and my family "secretly" are moving out today, I can tell the truth openly knowing that they are not there to do her any harm. Recently the police was called because one of the sons was having a marijuana party with his friends and the police did not arrest anyone even though there is probable cause. In the past, I called 911 on them several times for their belligerent behavior. This explains that the sons are using drugs and the Federal Government put my family into jeopardy.

All avenues to receive justice for the "human subjects" have been closed. They were never arrested. One police officer was coming to the house stating that I was calling 911 and I stated that I did not. I asked her how she knew where I lived. She stated that it was me who was calling 911. When I told her that I had a Maryland telephone number, she did not respond. I told her that this is identity theft and she tried to tell me it wasn't. Later, I went to the police station and I was approached by the same police officer and a policeman so that I could file my complaint against her. I asked for a copy of the 911 recording and the procedure for receiving a copy of the 911 recording and I was told that I had to be an attorney to receive it. I responded that I do not have to be an attorney to get a copy of the 911 recording. Her and another police officer were "perping" me as she told me that "no one is going to take your report". I have heard these words from several police officers. I left there sweating profusely because of what they were clicking in their pockets was causing my heart rate to increase.

The human subject is never supposed to be in contact with anyone who is not part of the syndicate, including the police. Over time, the same police officers would respond to my calls & would go into the house "pretending to talk to them, while sending "energy" into the house". Obviously, they were part of the syndicate cops called "Cousin Nancy". On page 24 of the Affidavit of Facts: Disclaimer to Opt-Out of NSA's PRISM, which is posted at www.ManifestTheTruth.com, it states, *"Cherrying" is the name for this secret process. The Bureau of Authority has a very organized system of lawyers, judges, Medical officers, etc. Whenever you're committing a crime for the good of the syndicate, you must always report your location. Then they send Cousin Nancy (this is an affectionate term for the police in the employment of the syndicate that they send to arrest you instead of non- syndicate cops, so you can go straight through the appropriate channels without anything suspicious being seen) to tail you and "arrest" you the moment somebody calls 911. They all follow a minimalist strategy though. For example, the mayor of Xxxxx isn't a member of the syndicate. But several of his advisors and aides are. This way we can get laws passed in a discreet manner, and if a high-profile figure is targeted, our hold on an organization doesn't loosen. We try to arrange elections of mayors that aren't too headstrong. Though the Government is mainly used as a minor nuisance. We prefer the courts for most activities."*

I had enough of planes and helicopters leaving their flight plans to drop "heaven knows what" in this room/house, which burns my skin, cause headaches, dry eyes, and pain throughout my body. I developed "raised black bumps" all over my arms. I had enough of eating radiation, a low flying drone shooting at my eyes while I am driving, and then the vehicles with the black-tinted windows doing the same. I had enough of waking up with dark, raccoon eyes and puffy eyes. I had enough of blisters appearing in my mouth after sleeping, after going out shopping, going to church or eating. I had enough of someone stealing my evidence. I had enough of stealing my money out of my bank account and then stealing the bank statements. I had enough of waking up with the soles of my feet being sore and swollen feet and ankles. I had enough of countless of vehicles following me everywhere I go. I had enough of things taking a lot longer to do or go. It took me 5 hours to get to Washington, DC because they wanted to show me their power. There were no accidents. They were mad because I called the White House to inform the President that NSA's PRISM is not the only research project, which uses involuntary or unwitting human subjects. I called back a second time, after the first operator abruptly hanged up on me. I asked this operator to include my website and he said that he couldn't take any personal information. He told me that I should write to the President. I stated that I did, but I do not believe that he received my correspondences, since the confirmation revealed that it was received at 4:00 am. I replied that another operator wrote down my website. I had enough of people entering my bedroom while I sleep and waking up to a laptop with no fingerprints on them. I had enough of my next door neighbors beaming me in the head with their weapons while I am doing the radio show in order that I would fall asleep. I had to leave the house and host the Blog Talk Radio Show in the vehicle.

I had enough of local police authorities not doing anything. I had enough of justice not being done and if anyone continues to hinder, delay, or stop any future criminal investigations or proceedings, they will be held accountable for their actions, as well as, for their inactions. I had enough of my e-mails and text messages about this Worldwide Prayer & Fasting event, my press releases, and prayers being returned undelivered. I had 100 email messages returned in one Gmail account and 52 messages were returned in another Gmail account. I had enough of being followed, stalked, & harassed where ever I go 24/7. I had enough of these "criminals" using these establishments including the church to beam me with their lasers, electronics weapons & even radiation. Other people are being exposed at Wal-Mart, Best Buy, Trader's Joe, Whole Foods, Wegman's, Perfecting Faith Church, Shiloh Baptist Church, Kohl's, Dollar Tree, Macy's, Shop-Rite, Staples, Barnes & Nobles to name a few. I submitted my "Affidavit of Truth do not destroy video surveillance tape form" to depict that a crime was committed because I was injured physically. Last week, I went after Christmas shopping and went to 3 Kohl's stores in Pennsylvania & New Jersey. By the time, I finished shopping, I could barely walk because the customers were beaming me with their electronics weapons, lasers, radiation or using their cell phones to cause my legs and feet to be so swollen that I could barely walk as pain was resonating in my lower back and twinkle of sweating was pouring down my back. My eyes became severely dry and I developed an excruciating migraine, which took hours to go away.

I am demanding that my remedies/reliefs are honored in the 40 page Affidavit of Truth today. I want tests to be done immediately to show the world that Jesus/Yeshua does exist and He saved me and my family from death. I had enough of being "fat". The prophet Jeanne S. informed me that they were concentrating on my "looks". I have never been fat ever like this in my entire life. I am ready to be a size 8 again and so is my sister. We are not really fat, but we are fully-loaded with radio frequency identification chips (R.F.I.D.)/implants. These implants are very painful especially when people are hitting my body with the lasers, electronics weapons or radiation. My body is retaining water in order to protect me from sustaining anymore bodily harm.

God is a God of justice. He does not believe that you are not taking me serious, because I am a woman and then a woman of color. I feel like a woman without a country because of what I have been through and the inability to get justice because of the informants are blocking my information from reaching the people to do something about it.

Research has an enormous budget, so God told me to start at the following figures for civil and punitive damages. The purpose is to determine if the Federal Government would help those who they "recruited" to do these heinous crimes against law-abiding, non-combatant men in America & International who are employed by the cities, counties, states, Federal Government, businesses/organizations, as well as, individuals? The original proposed figures have doubled since Christmas due to the lack of response by anyone, no mass media coverage, or real arrests of the perpetrators. Here are the original and the new proposed figures:

Cities- original \$300 million, now \$600 million
Counties – original \$400 million, now \$800 million
States – original \$500 million, now \$1 billion
Federal Government – original \$1.2 million, now \$2.4 billion
Individuals – original \$80 million, now \$160 million
Businesses/Organizations – original \$180 million, now \$360 million

Your time is up. When will you surrender or tell the truth now? After New Year's Day it will double again.

I cannot even enjoy going to church, without being targeted. Lies have kept me from speaking privately to Pastor Donnie McClurkin Jr. even though, I have written to him. I believe that my letters are being blocked by the informants who are

masquerading as “servants of God”. These people are strategically placed everywhere. I found them in other churches and ministries as well. They do not want this revival to occur in America. He is a key player, as well as, Apostle Guillermo Maldonado, Apostle Renny McLean & Apostle Esther Agiri. Apostle Esther even prophesized that they do not want this group to meet. I have sent e-mails to them, which all bounced back.

I still have an important message to deliver to him & not to anyone else. God sent me to Perfecting Faith Church seven years ago today & I will be going there tonight to bring in the New Year & I do not expect any problems there by “security” or feeling any radiation there. I will be asking PFC to keep their surveillance tapes for evidence that a crime is being committed. I cannot believe that people are using the house of God to do evil. I had enough. I do not believe that people will want to be sued for witness tampering, attempted murder, assault with a deadly weapon & treason/misprision of treason/seditious conspiracy. I have demonstrated to people with a stud finder that my body is riddled with radio frequency identification chips/implants. God has given me insight and I have been right about everyone that they have recruited to do these heinous crimes against me & my family including so-called Christians, my family members, and even neighbors. Someone should clean up the mess & tell the truth now to Pastor Donnie McClurkin Jr. He has lost a lot this year because of his anointing. I will do what I have been called to do. The curse of the Lord and His judgment will come upon anyone who continues to try to stop me tonight & from this day forward in Jesus’/Yeshua’s name. If I have to use the very people who have been close to me to expose the truth, I will. Prophet Jeanne S. confirmed some of my own family members, which I suspected, but I could not believe that they hated me so much to want me dead or they do not want me to get married. I have several “felonies”, which I can file with the police, but God told me to put them on hold until after tonight. Pushing and hitting me are considered assaults. I believe that many people will have a “spiritual awakening” beginning in 2014.

Silence is acquiescence.

I do not believe that the CEOs of Wal-Mart, Best Buy, IHOP, P.F. Chang’s, Hewlett-Packard, and Apple Bee’s to name a few would be happy if I asked people to join me in boycotting their stores because their employees sold me tampered products or intentionally sprayed my food with unknown contaminants to cause harm to my body. The police would not take my food to have it tested. I kept the food in the freezer and someone stole it out of the freezer. This modified HP laptop is causing my fingers to burn and the pain is resonating in my legs and feet and they have become swollen. This is why I am asking for a technology kit because I am being prevented from ordering another computer.

By the police accepting my “allegations” of filing police reports, they helped to substantiate that these events are occurring. Instead of investigating them, the police were told to document that these events occurred so they changed them to “police events”, which I never heard of before. The U.S. has 2 million prisoners, the largest in the world, but there are many who are walking free doing these heinous crimes to innocent men, women, & children in America & International because they are working for the U.S. Federal Government. **Many involuntary or unwitting human subjects can submit a warning to those who are violating the Color of Law, which is a felony to see if they cease & desist.**

Is this the standard protocol of the Intelligence agencies and military to intentionally select anyone that they want because they can? Who is going to stop them? These statements were told to me for the reason why three generations of her family are in this research.

We are passed the point of “internal investigations” of the Intelligence agencies & military. It will be a cover-up and honestly speaking, it will be another delay tactic. I went to the FBI in December 2010 and I did not hear back from them about my complaint. Recently, the U.S. Attorney’s office sent my package to the FBI and they have no clue about the status. More than likely, it went to an unscrupulous Federal Government agent. This is how they have been able to keep everything, such a well-guarded secret. In the remedies/reliefs, we are requesting that Congress constitute a tribunal for America and that the United Nations Security Council conduct the other one International based on what Microwave Expert Barrie Trower said last year. Research Proves that All “Human Subjects” Can Opt-Out of the Research or NSA’s PRISM at Any Time

Since June 6, the NSA’s PRISM is still collecting the phone records, email exchanges, and internet histories on countless of millions of Americans and possibly on the International community. How are they getting “human subjects” without obtaining their informed consent or knowledge? They are 2 options: the U.S. Common Rule, which allows a waiver requirement for informed consent or the researchers are going to court to get the waiver for informed consent.

As “human subjects”, they can opt-out or withdraw at any time without prejudice. It is stated in the United States and International Laws. The "Common Rule", 45 CFR 46. 116 (a) (8) states, "and the subject may discontinue participation at any time without penalty or loss of benefits to which the subject is otherwise entitled." OPT -OUT means to choose not to participate. Letitia Peters submitted her NSA’s PRISM Opt-Out Form that she developed, as well as, the 40 page Affidavit of Facts: Disclaimer to Opt-Out of the NSA’s Research to the National Leaders in early August and she has not received a response back from them. In November, she submitted her Affidavit of Truth and stated that they had defaulted and demanded that they honor her reliefs/remedies, which they have not responded to date.

Technology Used: What is Electromagnetic Radiation and Electromagnetic Energy?

Electromagnetic Radiation is being used on men, plants, animals, and in the environment. According to Wikipedia,

“Electromagnetic radiation (EM radiation or EMR) is a form of energy emitted and absorbed by charged particles, which exhibits wave-like behavior as it travels through space. EMR has both electric and magnetic field components, which stand in a fixed ratio of intensity to each other, and which oscillate in phase perpendicular to each other and perpendicular to the direction of energy and wave propagation. In vacuum, electromagnetic radiation propagates at a characteristic speed, the speed of light.

Electromagnetic radiation is a particular form of the more general electromagnetic field (E.M. field) that is defined as the field produced by moving charges. Electromagnetic radiation is associated with only the type of E.M. field which is far enough away from the moving charges that produced it, that absorption of the E.M. radiation no longer affects the behavior of these moving charges.

In general, E.M. radiation (the designation ‘radiation’ excludes static electric and magnetic and near fields) is classified by wavelength into radio, microwave, infrared, the visible spectrum we perceive as visible light, ultraviolet, X-rays, and gamma rays. The behavior of EM radiation depends on its frequency. Lower frequencies have longer wavelengths, and higher frequencies have shorter wavelengths, and are associated with photons of higher energy.

Electromagnetic radiation composed of photons that carry minimum-ionization energy, or more, (which includes the entire spectrum with shorter wavelengths), is therefore termed ionizing radiation. (There are also many other kinds of ionizing radiation made of non-EM particles). Electromagnetic-type ionizing radiation extends from the extreme ultraviolet to all higher frequencies and shorter wavelengths, which means that all X-rays and gamma rays are ionizing radiation. These are capable of the most severe types of molecular damage, which can happen in biology to any type of biomolecule, including **mutation and cancer**, and often at great depths from the skin, since the higher end of the X-ray spectrum, and all of the gamma ray spectrum, are penetrating to matter. It is this type of damage, which causes these types of radiation to be especially carefully monitored, due to their hazard, even at comparatively low-energies, to all living organisms.

Electromagnetic energy can be used to influence, disable or kill humans at a distance. The spoken word of the hypnotist may be conveyed by modulate electromagnetic energy directly into the subconscious parts of the human brain. Almost anything could be inserted into the target brain-mind systems.

Electromagnetic energy could be used to prevent voluntary muscular movements, control emotions & thus actions, produce sleep, transmit suggestions, interfere with both short-term and long-term memory, produce an experience or delete an experience. A microscopic brain chip can also be implanted.”

Role of Media

Media also plays an important role in the stories pertaining to telling the public about “mind control experimentation”, which is distorted and not the full truth. “Refusal of the mass media to address this topic, except in those cases where suspected experimentees have been driven to the point of committing murder or suicide.

“Such cases (particularly where an individual has claimed to be the victim of CIA-directed mind-control involving auditory input) are treated by the press as “curiosities.” An example of this is the individual who shot a Navy officer outside the Pentagon in mid-1991. This story was reported in *The Washington Post*, June 1, 1991, p. C-1 (“‘Voices’ Led to Tragedy for 2 Men/Pentagon Suspect’s Mother Says Institutions Should Have Held Son”) and December 14, 1991, p. D- 3 (“Suspect in Pentagon Killing Is Found Unfit to Stand Trial”).

He claimed to be a victim of CIA mind control, involving auditory input. According to the press, “he worried ‘about being run over by trains’...” (ref. incident described in following paragraph). He is now permanently residing in a psychiatric facility. He, being institutionalized, and others in the preliminary stages of his predicament are no longer of interest to the media.”

Here are some questions, which the media has failed to ask: Can the military experiment “secretly” on their enlisted men or women? Does the Federal Tort Claims Act (FTCA) grants the military the power to experiment on its soldiers without their consent? Some of the facts explained by Mr. Trower include:

- Society really had no ‘need’ for advanced telecommunication technology.

- Telecommunication industry is the most powerful industry on the planet.

b. **Former Army Intelligence Officer Julianne McKinney, "Microwave Harassment and Mind Control Experimentation"**

Former Army Intelligence Officer Julianne McKinney was appointed as director of the electronic surveillance project and in 1992 she authored the publication "Microwave Harassment and Mind Control Experimentation", which still is recognized today as one of the most authoritative document on the subject. **In the 32 page document, she discusses the overt harassment and related covert methodologies that are being used on the “Targeted Individuals” (TIs)/“human subjects”. Many of the surveillances, which are described in her publication, can be called COINTELPRO.**

Former Army Intelligence Officer, Julianne McKinney’s 1992 publication, *Microwave Harassment and Mind Control* wrote,

“our first step was to determine what, if any technology exists which might be used for electronic harassment. That information was found in a “white paper” published in 1991 by the U.S. Global Strategy Council—a Washington-based organization, under the chairmanship of Ray Cline, former Deputy Director of the CIA, who maintains very close ties with the U.S. Intelligence community. The “white paper” describes the foreign and domestic uses foreseen for laser weapons, isotropic radiators, infrasound, non-nuclear electromagnetic pulse generators, and high-power microwave emitters.”

The “Preliminary Findings” revealed the following:

Preliminary Findings

1. The technology exists for the types of harassment and experimentation reported to us.
2. About a dozen U.S. citizens have informed us of continuing experiences with effects which directed-energy weapons are designed to produce.
3. U.S. Government-sponsored research into the bioeffects of exposure to microwave radiation is extensive and continuing.
4. The U.S. Government has a past record of having engaged in mind-control experimentation; and various agencies of the Government have a record of circumventing legal restrictions upon their activities.
5. Neither Congress nor the courts appear willing to look closely into “black” intelligence and weapons procurement programs.
6. A number of U.S. Government agencies might have interest in testing directed-energy technologies on U.S. citizens under non-clinical/non-controlled circumstances—DoD, to test ranges and degrees of “non-lethality”; DoE, to explore “safety” limits; CIA, to test “mind-control” capabilities, and NSA, for technological refinement.

The detailed sections of the Existed Directed Energy-Arsenal, Bioeffects of and Microwave Radiation for which the preliminary findings were based on are discussed in detail in her document.

Miss [deleted] expressed absolute denial that the foregoing sequence had happened." ([CIA Mori ID 190691](#), 2/10/54)

In a 1971 *Science Digest* article, Dr. G.H. Estabrooks states, "By the 1920's clinical hypnotists learned to split certain individuals into multiple personalities like Jeckyl-Hydes. During WWII, I worked this technique with a Marine lieutenant I'll call Jones. I split his personality into Jones A and Jones B. Jones A, once a 'normal' working Marine, became entirely different. He talked communist doctrine and meant it. He was welcomed enthusiastically by communist cells, and was deliberately given a dishonorable discharge. Jones B was the deeper personality, knew all the thoughts of Jones A, and was 'imprinted' to say nothing during conscious phases. **All I had to do was hypnotize him, get in touch with Jones B, and I had a pipeline straight into the Communist camp.**" (*Science Digest*, April 1971, pp. 44-50)

The Existence of the Technology Used for Electronic Harassment

The Existing Directed-Energy Arsenal

Our first step was to determine what, if any technology exists which might be used for electronic harassment. That information was found in a “white paper” published in 1991 by the U.S. Global Strategy Council—a Washington-based organization, under the chairmanship of Ray Cline, former Deputy Director of the CIA, who maintains very close ties with the U.S. Intelligence community. The “white paper” describes the foreign and domestic uses foreseen for laser weapons, isotropic radiators, infrasound, non-nuclear electromagnetic pulse generators, and high-power microwave emitters.

The term, “non-lethal,” used to describe this technology is misleading. The energy emitted from all of these weapons can kill when appropriately amplified. At lower levels of amplification, they can cause extreme forms of physical discomfort and debilitation.

The Department of Army (DA) identifies these same weapons as “non-conventional.” They were so identified in an exhibit at a DA-sponsored symposium on “The Soldier As A System,” in Crystal City, VA, on June 30, 1992. Beta wave incapacitators were separately mentioned during the symposium as being of particular interest to the U.S. Marine Corps.

We discussed these “non-conventional” directed-energy weapons with Mr. Vernon Shisler, manager of the exhibit and the Army’s delegate to NATO in matters pertaining to “The Soldier As A System.” Mr. Shisler acknowledged not only that directed-energy weapons are in DoD’s arsenal, but also that the American soldier will remain vulnerable to their effects, should they be employed in the battlefield.

The U.S. Global Strategy Council recognizes the issue of vulnerability, as well, and urges ongoing research into effective countermeasures.

Bioeffects of Microwave Radiation

Research into the biological and psychological effects of exposure to microwave radiation is voluminous. The U.S. public has been led to believe that the former Soviet Union leads in this research. **The fact is, the CIA and DoD [Department of Defense] have jointly pursued precisely the same research since commencement of Project Pandora in the 1950’s. The current primary users of this research appear to be the CIA, DoD, the National Security Agency (NSA) and the Department of Energy (DoE).**

The Walter Reed Army Institute of Research (WRAIR) has participated in this research since Project Pandora. In 1973, WRAIR discovered that externally-induced auditory input could be achieved by means of pulsed microwave

audiograms, or analogs of spoken words' sounds. The effect on the receiving end is the (schizophrenic) sensation of "hearing voices" which are not part of the recipients' own thought processes.

The experiment prompted the following comment in *The Body Electric: Electromagnetism and the Foundation of Life*, by Robert O. Becker, M.D., and Gary Selden (Wm. Morrow & Company, NY, 1985): "Such a device has obvious applications in covert operations designed to drive a target crazy with 'voices' or deliver undetectable instructions to a programmed assassin."

This research has continued, and the results are published in various publicly available scientific and technical journals. Interested readers might consult, for example: Lin, James C., *Electromagnetic Interaction With Biological Systems* (Plenum Press, NY, 1989). Professor Lin, then with the Department of Bioengineering, University of Illinois, Chicago, has published a number of books and articles on this subject. [He has more recently informed us that he had designed the experiment referenced above in Dr. Becker's book.]

WRAIR has more recently been studying the biological effects of exposure to high-power microwave radiation. WRAIR presented a paper on this subject to a DoD-sponsored symposium on "MW [microwave] Weapons" at the Naval Postgraduate School in Monterey, CA, in mid-1989.

A matter of interest to us is why WRAIR should be experimenting with auditory effects of pulsed microwave audiograms. Also, recent statements by an Army psychiatrist assigned to the Walter Reed Army Medical Center (WRAMC) suggest that WRAIR may be experimenting upon select psychiatric inpatients with microwaves. This, too, is a matter of interest to us.

Refusal of Mass Media to Address the Testimonies of Modern-Day Survivors

Is mainstream media in America being told not to cover these stories, threatened, bribed, or blackmailed? There was only newspaper, which reported about the testimonies of the modern-day survivors: American Free Press. In the May 6 & 9, 2011 editor, Mr. Thorn's article, *Bioethics Ethics Ignores Modern Day Abuses* states,

"Saddest of all, the public rarely sees a glimpse of these extreme tortures because, when the 20 victims approached Ms. Gutmann and her Bioethics Commission, every member of the media present that day stood up and immediately left. All of these so-called journalists showed they are more than willing to promote the Obama agenda by focusing on past horrors, while ignoring the people still being abused today.

Considering the long, well-documented history of secretive intelligence programs such as MK-ULTRA, if U.S. congressmen are fair game for mind control, should anyone be surprised that tests are still being conducted on everyday citizens without their consent? Or, as (late Ted) Gunderson commented, "This makes the old COINTELPRO program look like a Boy Scout jamboree." One survivor ... Nobody should have the right to maim or torture any other person or to treat them in the cruel manner that I have been treated under the guise of national security." Texas doctor John Hall spoke of an alarming rate of complaints associated with the use of radiation weapons that are debilitating victims. Author Allen Hornblum, who has written on the use of prison inmates and children as test subjects, emphasized, "Medical ethics is an orphan in today's medical arena." In the next meeting, the Bioethics Commission announced that the Guatemala Syphilis Experiment was condemned "unethical" and it received mass media coverage in America and International.

American Free Press has published several stories about the non-consensual human subjects. Letitia Peters has hand-delivered 2 packages to their Washington, DC office. She even talked to the editor about her story, but she never heard back from anyone about doing her story. They did run a story about Laura Poitras.

In the April 23 & 30, 2012 edition of the American Free Press, (www.AmericanFreePress.net), "Press Targeted by DHS" details how Laura Poitras, an Oscar and Emmy-nominated filmmaker and intrepid journalist who has been targeted and the

Department of Homeland Security has been forced to admit that in six years **they never found anything to justify their continuing abuse and harassment other than they didn't like her expressing non-official viewpoints.**

Obviously, the Intelligence agencies are using their influence to control what is being reported in the news.

Aaron Alexis experienced sleep deprivation. He did "hear voices in his head". This is confirmed by Microwave Expert, Dr. Barrie Trower who states in his "Barrie Trower Talks with Victims of Non-Consensual Microwave and EMF Experimentation and Testing" interview at <http://youtu.be/09mpvscHiKI> that "some people are targeted for research. Some people are sensitive. Some people are just, very slightly sensitive but becoming more sensitive and other people may be sensitive to particular different frequencies. **The problem we have here today is that under direction of the U. S. Government in 1976, most of the western countries, Australia, Britain, Canada, & the U.S. They were all advised to keep everything to keep it secret so that the Military and the Industry could be protected, you could protect their profit margin and if the people in the Military knew that the equipment that they were using could give them tumors, then they could start lawsuits. So the advice in 1976 from the American Government was not to tell people the truth. Keep it secret.**" He has documents that prove that people are being paid to experiment on people without their consent. Deborah Poulsen states, "Thousands have the same stories and or symptoms. We've come together and talked." English Physicist Dr. Barrie Trower states in response, "This is known, if we go back to between, so that the 50', 60's, 70's, 80's, if we look at that era, even the 90's. I have documents you are welcome to copy for which the English, Australia, United States CIA, The Departments DIA, Defense Intelligence Agency with Associated Universities and the Canadian Secret Service have experimented on around five hundred thousand for over forty years consisting of the poor, psychiatric patients, pregnant women, children over the age of four, Muslims', Catholics, and Service Personnel. The Service Personnel selected were young and fit, making it an ideal epidemiologist study. Five hundred thousand was experimented on. I have the summary of the experiments and two statements which are worth reading. The British were involved in this as well from 1986 after five hundred thousand were experimented on. A man from Naval Surface Weapons Center in the United States said, "We can change behavior of cells, tissues, whole organisms," in other words any part of the body. "We can have a six times higher fetal mortality rate, cause birth defects and induce malignant tumors in human cells." From 2001-2007 there was a secret course held. Number eleven on this course the opening statement was, "Students who will be familiar with current knowledge, which is cancer, memory, brain dysfunction, and damage to the eye, skin and birth defects from radio frequency, microwave radiation." MKULTRA, I think it had a budget of one hundred and sixty million dollars or something and the one project there were 262 separate human experiments, like on the poor, the children, it wasn't just microwaves. They used all other frequencies, they used microwaves with hypnosis, microwaves with drugs, they used combinations of things and **their boast was they could, I know they could induce any psychiatric illness that would fool a psychiatrist so that they could instill psychosis, schizophrenia, paranoia, they could also bring on blindness, heart attacks, liver dysfunction, heart dysfunction, anything in the human body just by targeting that organ and they still can.** He also stated, "They didn't anticipate how quickly the cancers and the bad behavior would come in. So, with TETRA throughout Europe really, when you have experimented on 500,000 people and caused deaths and **had them committed asylums for the rest their lives just to experiment and caused women to have miscarriages, birth defects, genetically deformed children.** Once you've done all that, having a few police officers and ambulance workers and people die is really immaterial because there are plenty more to join, there are plenty of jobs. So, and I think it's from the American Government's point of view it's we'll get the British to force this out, is which is what Blaire and Bush did, okay so some people are going to die throughout Europe but we can at least listen to all the conversations, you know, **because there are better systems and safer systems and they were warned by people like me.**"

One Objective of the "Human Subject" Research is to Create a Perfect, "Robotized" Soldier

In December 1992, Julianne McKinney, former Army Intelligence Officer and former Electronic Surveillance Project Director for the Association of National Security Alumni published the "Microwave Harassment & Mind-Control Experimentation", which is the most authoritative document on the subject. It can be downloaded on various websites including www.ManifestTheTruth.com. **In the 32 page document, she outlines several objectives of the "human subject" research projects and identifies one of the objective is** "to develop an effective means for creating a perfect, "robotized" soldier." MKULTRA (survivors were kept on the books), PAVLOVIAN EXPERIMENT and PROJECT SLAMMER are listed as human subject research projects, which clearly violates the rights and welfare of the "human subjects".

Twenty-one years later, we received confirmation by talking with several non-consensual, involuntary or unwitting “human subjects” that their bodies can be controlled by other people. This may sound science fiction, but it is true. In the “perp’s” confession, it states,

“This research is about having complete control over a person. This can be done by placing “human subjects” into a “hypnosis state.” It appears like the “human subjects” are themselves, but the “perps” have taken over their bodies & the “human subjects” have no recollection of what they did or said. This is being done because the “perps” are connected to the implants/R.F.I.D. chips in their bodies. They can cause the “human subjects” to wake up, give them a headache, urinate on themselves, move their body parts, and cause pain in any part of their bodies where the implants/R.F.I.D. are located.”

Another Objective of the “Human Subject” Research is to “Break the Human Subjects”

The researchers/informants are boasting that they are not going to prison because the “Government” hired them to do a job, which is to **“break the human subjects”**. They can do anything to the human subject “within reason.”

Former Army Intelligence Officer, Julianne McKinney’s 1992 publication, *Microwave Harassment and Mind Control Experimentation*, (this publication is available on the Internet to download), documented several objectives. It states, “this individual’s “handlers” allegedly have also stated that their experiments on U.S. citizens are in pursuit of a variety of objectives:” In Julianne McKinney’s document, it states, “Several individuals, thinking that psychiatrists might help to alleviate the extreme stress associated with their harassment, were accorded “treatment” which clearly pointed to cooperation between their psychiatrists and members of the U.S. Intelligence community. One such psychiatrist, in fact, bragged about being a member of the U.S. Intelligence “inner circle,” **informing our contact that her harassment was a “Pavlovian Experiment,” intended to “break” her.**

Twenty-one years later, it was discovered that this is still one of the objectives of the research is to “break the human subjects” and it was confirmed by several “perps” in interviews.

Ms. Peters states, “The researchers/informants/perps were told that they can do anything **“within reason”** to “break” us; financially, emotionally, physically, even getting us wrongfully committed to a mental institution or prison. They were told to “ruin our lives. While the “perps” are stealing our monies, poisoning us, raping us, drugging us, torturing us and continuing to “anything within reason” to us until we “break”. They are breaking in and out of our homes, computers, cameras, bank accounts and autos without showing signs of a break-in. This is called **covert entry** & only the Intelligence agencies are taught this trade, but they are teaching their “secrets” to the “perps” are being, which violates Federal Law as stated in fact 5. The “perps” were told that that they can do ANYTHING to the “human subjects” within reason. What is meant by “within reason”? **None of this is within reason. They have confessed that they committed acts, which was not authorized. A judge was “secretly” implanted so that the targeted individual would lose her case.**

The big difference is that we are not in the military. Now, they are no longer including just chemical weapons, but also electromagnetic radiation, electronics weapons, and even mycotoxins, which is a biological weapon. This may explain why mold is coming out of my body because I am not living in an unhealthy mold environment.

This concept of “break” a man is from the Department of Defense (DoD). This is documented on May 6, 1994, Senator John D. Rockefeller IV shared with members of the Committee on Veterans’ Affairs, he stated,

“Some of the studies that have been conducted had more questionable motives. For example, DoD now admits they conducted “Man Break” tests, **exposing soldiers to chemical weapons in order to determine how much was necessary to “break a man”**. Similarly, DoD admits that they subjected hundreds/thousands of soldiers to hallucinogens without their knowledge or consent, in an effort to determine how incapacitating those substances could be. Most Americans would agree that the use of soldiers as guinea pigs in experiments that were designed to harm them is not ethical.”

This military concept is being used on civilians, which was designed to harm is not ethical and the research should be terminated or suspended. They cannot do whatever they want to us. That is another lie. Researchers are bound to a code of ethics, but the research projects are no longer protecting the “human subjects” from physical or psychological harm, protection from privacy and confidentiality, or protection against unjustifiable deception. The non-consensual “human subjects” are oppressed by the technology (i.e. cell phones, electromagnetic radiation, lasers, electronic weapons, implants/R.F.I.D. chips, drones, etc.) which violates our human, civil, and constitutional rights.

According to DoDI Federal Policy on Research Misconduct 3210.7 dated May 14, 2004 in section E.4.16, it states, “The research institution is required to provide immediate notification at any time if:

E.4.1.6.3 Research activities are to be suspended because of the inquiry into or investigation of the allegation.

E.4.1.6.4 There is a possible violation of civil or criminal law.”

Pandora should be terminated immediately.

Discredit the “Human Subjects” by Diagnosing them with a Mental Illness like the Late Elmer Allen in order to Continue with their Unethical Research/Experiment on them for Life

The United States has a long history of conducting research on its own citizens without getting informed consent. Many “human subjects” have been diagnosed with a mental illness in order to discredit them so that they can continue with their unethical human subject research/medical experiment on them. It is also part of their active denial protocol.

Microwave Expert, Dr. Barrie Trower states,

“They follow a system, they Police, the Governments’, the Secret Services’, anybody who has authority in these countries they all follow the same advice and it’s called, “Active Denial.” **It’s called, “Active Denial.” The moment you say anything, bang it’s not true, it doesn’t happen, “Active Denial.”**

During the Cold War, it is **documented in official federal government medical records/documents that the federal government scientists diagnosed many non-consensual “human subject” with “neurosis” or “paranoid schizophrenic” when they stated they were being experimented on by them.** For example, this was documented in the case of the late Elmer Allen.

The sad part about Elmer Allen’s story is that nobody believed him. **He went to his doctor and told him, “I think I’ve been injected with something.” His doctor diagnosed him as a paranoid schizophrenic at the same time that he was conversing with the atomic energy scientists in Argon National Lab to provide them with tissue samples. Elmer Allen was not only used in 1947 when he was injected with this radioactive isotope, but he continued to be used as a guinea pig for the rest of his life.** When Elmer Allen’s daughter, Elmerine was interviewed, she told the story of when she left for college, her father would tell her watch out, “Don’t let the U.S. government guinea-pig you.” And they always thought that Elmer Allen had some kind of, well, Elmer was kind of quirky, and he had this delusion that the government experimented on him.

In the 1970’s, a **second generation of atomic scientists rediscovered this experiment.** So they wanted to dig up all the people who were dead, who had been injected with plutonium, and they also wanted to bring whoever survived them back into the lab for further studies. Elmer Allen was one of those people who was still alive.

Like Elmer Allen, many involuntary or “unwitting” “human subjects” have been labeled as “crazy”, “delusional” or been diagnosed with a “mental illness”. It was only the Atomic Energy Scientists in Elmer Allen’s case, but now the playing field as expanded exponentially.

Now it includes the following, but it is not limited to: police officers, psychiatrists, judges, physicians, federal intelligence agents, family members, friends, and associates are being used to discredit the involuntary or “unwitting” “human subjects”.

Many human subjects have been declared with the mental illness of schizophrenia in order to discredit them.

a. ACHRE’s Report Confirms that during the Cold War Era Government Officials Diagnosed Women Exposed to Radiation with “Neurotic” or “Housewife Syndrome”

The ACHRE’S report depicts that Government officials made them think that they were “crazy”, but in essence, they were telling the truth. Here’s the excerpt from the ACHRE’s report:

Disinformation and Nuclear Fallout

“In the nuclear arms race, government doctors and scientists brainwashed the public into believing low dose radiation was not harmful. Some officials even tried to convince people that “a little radiation is good for you.” Totally ignored was the knowledge that the radiation from nuclear fallout could lead to an increased risk of cancer, heart disease, neurological disorders, immune system disease, reproductive abnormalities, sterility, birth defects, and genetic mutations which could be passed on from generation to generation. The full extent of this radiation damage to the American public during the Cold War years will never be known.

A secret AEC document, dated 17 April 1947, reveals that physicians were aware of these radiation hazards but simply ignored them. Under the title “Medical Experiments in Humans,” the memorandum read: “It is desired that no document be released which refers to experiments with humans that might have an adverse effect on public opinion or result in legal suits. Documents covering such field work should be classified ‘Secret’.”

According to Gallagher, many downwinders testified that the Public Health Service officials told them that their ‘**neurosis**’ about the fallout was the only thing that would give them cancer, particularly if they were female. Women with severe radiation illness, hair loss, and badly burned skin, were clinically diagnosed in hospitals as “**neurotic.**” Other severely ill women were diagnosed with “**housewife syndrome.**”

2. Microwave Expert Dr. Barrie Trower: “Commit them to Asylums to Experiment on them for the Rest of their Lives”

Many non-consensual “human subjects” have been wrongfully committed to mental institutions and given a diagnosis of schizophrenia, neurosis, or other mental illnesses. **There are unscrupulous physicians and psychologists who has intentionally misdiagnosed a “human subject”** with a diagnosis of schizophrenia, neurosis, or other mental illnesses in order to commit them to a mental institution and to discredit them, even though they do not meet the criteria to be diagnosed as a paranoid schizophrenia.

Microwave Expert Dr. Barrie Trower has stated that the “**U.S. had them committed to asylums for the rest their lives just to experiment on them.** They used all other frequencies, they used microwaves with hypnosis, microwaves with drugs, they used combinations of things and that ah and their boast was they could, I know they could induce any psychiatric illness that would fool a psychiatrist so that they could instill psychosis, schizophrenia, paranoia, they could also bring on blindness, heart attacks, liver dysfunction, heart dysfunction, anything in the human body just by targeting that organ and they still can.”

While there are many “human subjects” that have been wrongfully diagnosed or committed to a mental institution and therefore, their records should be expunged and they should be released from the mental institution.

All “human subjects” who have been declared with a mental illness should be examined for medical implant devices.

c. Mental Illness Diagnosis of “Human Subjects” : Schizophrenia

Many “human subjects” have been diagnosed with the mental illness of schizophrenia. Many of them are not delusional and they are “hearing voices”. “Schizophrenia is a disease that typically begins in early adulthood; between the ages of 15 and 25. Men tend to get develop schizophrenia slightly earlier than women; whereas most males become ill between 16 and 25 years old, most females develop symptoms several years later, and the incidence in women is noticeably higher in women after age 30. The average age of onset is 18 in men and 25 in women. **Schizophrenia onset is quite rare for people under 10 years of age, or over 40 years of age.** Schizophrenia is a devastating disorder for most people who are afflicted, and very costly for families and society. The [overall U.S. 2002 cost of schizophrenia](#) was estimated to be \$62.7 billion, with \$22.7 billion excess direct health care cost (\$7.0 billion outpatient, \$5.0 billion drugs, \$2.8 billion inpatient, \$8.0 billion long-term care)”. ([Source: Analysis Group, Inc.](#))

Another Method: Gaslighting

In Wikipedia, it states, “Gaslighting is a form of [psychological abuse](#) in which false information is presented with the intent of making a victim doubt his or her own [memory](#), [perception](#) and [sanity](#). Instances may range simply from the

[denial](#) by an abuser that previous abusive incidents ever occurred, up to the staging of bizarre events by the abuser with the intention of [disorienting](#) the victim.

The term "gaslighting" comes from the play [Gas Light](#) and its film adaptations. The term is now also used in clinical and research literature.

The term "gaslighting" has been used colloquially since at least the late 1970s to describe efforts to manipulate someone's sense of reality. In a 1980 book on [child sex abuse](#), [Florence Rush](#) summarized [George Cukor's](#) 1944 film version of *Gas Light*, and writes, "even today the word [gaslight] is used to describe an attempt to destroy another's perception of reality". The term was further popularized in Victor Santoro's 1994 book *Gaslighting: How to Drive Your Enemies Crazy*, which outlines ostensibly legal tactics the reader might use to annoy others.

Clinical examples

Psychologist [Martha Stout](#) states that [sociopaths](#) frequently use gaslighting tactics. Sociopaths consistently transgress social mores, break laws, and exploit others, but are also typically [charming](#) and [convincing liars](#) who consistently [deny wrongdoing](#). Thus, some who have been [victimized](#) by sociopaths may doubt their perceptions. Jacobson and Gottman report that some [physically abusive](#) spouses may gaslight their partners, even flatly denying that they have been violent.

It is like a scene from the movie, *Gaslight* (1940). Here are the paraphrase words to sum up our situations,

Quite by accident, I discovered their identities and now I am dangerous to them. They have to slowly and methodically drive me out of my mind. They could not get rid of me by ordinary means for fear of an inquiry. They got to discredit me and fast. In order to discredit anything that I was saying they have to drive me crazy or get me declare as a "raving lunatic".

Last weekend, the movie "Gaslight" was on TBN and actress Drew Barrymore stated that an old boyfriend was "gaslighting her". People are aware of this that this is happening to them. My neighbors would "gaslight" me all the time. I spent so much time looking for things. They would take stuff out of my room and put it into my vehicle bypassing my security system. This is part of the active denial protocol that this is not happening to the involuntary or unwitting "human subjects" so this would allow the researcher to continue the unethical, medical experiments without any inquiry or investigation. Who would believe a "crazy" person or someone who has a mental illness? Now the committed "human subject" is afraid to speak out about his/her ordeal because they fear that they might be recommitted again and this time even longer or permanently. When the "human subject" starts talking about the "so-called experiment", it is easily brushed off as a "delusion" and they are even threatened with being sent back to the mental institution for further analysis if they bring it up again. The committed "human subject" is forced to keep silent about their horrific ordeal because they have no one who would believe him/her. As a result of feeling abandoned or a sense of hopelessness, they result to committing suicide or they are murdered to look like a suicide or that they died of a disease.

This tactic is also a form of adult "bullying" in order to intimidate the non-consensual "human subject" to keep silent about his/her experiences, while the unethical medical experiment continues. It can also be perceived as an "abuse of power" as well.

Activist's Research Uncovers Violation of the Rights & Welfare of the "Human Subjects" and Criminal Activities

This is an ingenious plan, which has many different layers, which Ms. Peters was able to discover. Sec. 2381. Treason

Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States. **This is TREASON.**

Sec. 2382. Misprision of treason

Whoever, owing allegiance to the United States and having knowledge of the commission of any treason against them, conceals and does not, as soon as may be, disclose and make known the same to the President or to some judge of the United States, or to the governor or to some judge or justice of a particular State, is guilty of misprision of treason and shall be fined under this title or imprisoned not more than seven years, or both. (NOTE: Letitia Peters sent her Affidavit of Facts: Disclaimer to Opt-Out of the NSA’s PRISM to the New Jersey Governor Christie & her 14 page Opt-Out Form for this

Many people are guilty of “Misprision of TREASON”.

Sec. 2384. Seditious conspiracy

If two or more persons in any State or Territory, or in any place subject to the jurisdiction of the United States, conspire to overthrow, put down, or to destroy by force the Government of the United States, or to levy war against them, or to oppose by force the authority thereof, or by force to prevent, hinder, or delay the execution of any law of the United States, or by force to seize, take, or possess any property of the United States contrary to the authority thereof, they shall each be fined under this title or imprisoned not more than twenty years, or both.

Many people are guilty of Seditious Conspiracy.

Two or more persons have prevented, hinder, or delay the execution of law in the U.S., which is “**Seditious Conspiracy**”.

According to Wikipedia, “**targeted killing** is the intentional killing, by a government or its agents, of a targeted person, whom they may consider an “unlawful combatant”, who is not in their custody. The target is a person who is allegedly taking part in an armed conflict or terrorism, whether by bearing arms or otherwise, who has allegedly lost the immunity from being targeted that he would otherwise have under the Third Geneva Convention.”

Many people have contacted the FBI and they have not done investigated the allegations. This is a deliberate, targeted assault on non-combatant American citizens and it is happening in the jurisdiction of the United States of America. **This is DOMESTIC TERRORISM.**
