Dear President Clinton:

I appreciated your prompt and courteous response to my letter dated November 15, 1994. Copies of these letters are attached for your immediate reference.

While I did indeed appreciate your letter, I am concerned that your National Security Council staff appears to have overlooked two major points raised in my letter to Dr. Lamb; viz., concerning the role of (clearly-unmonitored) major defense contractors in the testing and development of these directed-energy systems; and the unresolved plight of U.S. citizens who are still on the receiving end of this experimentation. Dr. Lamb has chosen not to reply to my letter. Your assistance in resolving these issues would be most gratefully appreciated.

As to DoD's claims regarding their lack of involvement in involuntary human experimentation, you might want to read DoD Directive 5240. 1-R ("Procedures Governing the Activities of DoD Intelligence Components that Affect United States Persons"). **According to this regulation, persons who qualify as "targets of surveillance" become fair game for the testing of all forms of communications and "non-communications" frequencies.** Radar is identified in this regulation as a "non-communications" frequency. (Radar is also now being touted as a "non-lethal" asset.) Also according to this regulation, signals testing and experimentation in "targets of surveillance" may involve the joint participation of the Central Intelligence Agency.

Your Foreign Intelligence Surveillance Court (FISC) has obligingly furnished DoD and other U.S. Intelligence agencies a rubber-stamp authorization to test these technologies on more than 6,500 alleged “spies” in this country between 1979 and 1991, alone. God only knows how many additional “spies” have been added to the list since 1991. The FISC is accountable to no one. FISC surveillance authorizations serve merely to legitimize involuntary human experimentation now ongoing in this country. Rogue DoD contractors, I might add, are exercising the luxury of not having to concern themselves with these FISC formalities.

DoD has informed your National Security Council staff that it “does not conduct any human testing on unwitting or involuntary subjects” (emphasis mine). The involuntary human experimentees referenced in my letter to Dr. Lamb are fully “witting” – a situation compelled by the nature of the experimentation, itself. By having become “witting” (if helpless to do anything about it), these experimentees apparently meet one of DoD’s two criteria for continued experimentation; namely, that either they be “witting” or that they be “voluntary.” DoD’s response to your National Security Council staff embodies duplicitousness.

As a matter of interest, I arrived home after spending Christmas with my family, not only to find that your letter had arrived, but, also, to find that the rubber insulation on one of my lamp cords had been deliberately shaved down during my absence for purposes of “inadvertent” ignition. The spark which “inadvertently” leaped out of the exposed copper wires last night was only inches from the fringe on my bedspread.

This is only about the tenth such (plausibly-deniable) attempt on my life since this Project commenced in mid-1992. It would appear, so far, that I have a choice of being run off of the road at a high speed, of being blown up by a gas stove, of being electrocuted or, now, of being fried in an “inadvertently”-ignited inferno.

I am bringing this to your attention because these recurrent attempts would appear to belie the officially-benign position taken by the Department of Defense regarding involuntary human experimentation. Indeed, I am being given the distinct impression that U.S. citizens who push for investigations into these experiments face a future on a morgue slab. This is not my idea of how a democracy should operate. Perhaps I am mistaken.

I frankly do not relish the thought of being assassinated for pursuing a subject which this government would obviously prefer not be discussed. I do not intend to stop, regardless.

As stated in my previous letter to you, you have made a fine beginning where potential revamping of our National Security Agenda might be concerned. Please do not draw the line, so to speak, where non-ionizing radiation is concerned. Lives of U.S. citizens are being destroyed because of these experiments.

LETITIA PETERS INTERVIEW WITH WOMAN JOY FROM IOWA, A “NON-CONSENSUAL HUMAN MICROCHIPPED HUMAN SUBJECT.” On September 11, 2012

Legend: Originally from Denison, Iowa and now resides in Omaha, Nebraska

1. Letitia Peters
2. Joy (Non-Consensual Human Subject)
3. Roger Boehm (Perp 1)
4. Ken Schaben (Perp 2)
5. Craig Jensen (Perp 3)
6. Larry Campbell (Perp 4)

Letitia: “You had something you wanted to say to the, to anybody if they were listening what would you say about being a “Non-Consensual Human Subject?””

(Female Non-Consensual Human Subject): “It was more than just going to a doctor with a toxic-clinical [something] prescription to end my suffering or gaining a pill that would make the suffering go away. I’ve been through so much torture and pain that it is heart breaking and I can’t wait till we change [around] because my rights have been walked all over. It’s like I didn’t have no civil rights and the tormenting that I have gone through in the last 25 years was very, very, very hard on me.”

Letitia: “Are they around now? Do they want to talk or are they scared?”

(Non-Consensual Human Test Subject): “No we’re, they are not scared to talk to you. But they talk when they want to talk. [God’s thing is] [Mechanical Interruption/Time missing]

(Male Perp 1): The reason why we chipped this woman is because I’m obsessed with her. No, I’m in love with you Joy. When’s the last time the real Joy saw you?

Letitia: And who are you? What’s your name?

(Female “Joy” Non-Consensual Human Subject): (1 Roger Boehm Perp): “Roger Boehm and I had her chipped! Legally!”

Letitia: Why you had her chipped?

(1 Roger Boehm Perp): Because I wanted her for my own.

Letitia: But that's not right.

(1 Roger Boehm Perp): No, it's not right.

Letitia: You made her suffer all these years, for what?

(1 Roger Boehm Perp): You think I care!? I often come in and rape her!

(Female "Joy" Non-Consensual Human Subject): Yeah, I've been raped, repeatedly raped throughout these years of targeting. The way they get in at night without me letting them in is the way they are raping me. Kind of like a Dr. Jekyll and Mr. Hyde thing. They, mine, with their dials of their controllers of the receiving end my chips I know that they can turn the dials down and the dials up that cause me great pain. I know that they can often make me go into an unconscious state of mind what they call a "Sweet Mode" and have induced dreams. With all these Direct Energy Weapons (DEWs) I'm always being attacked every single day. I am tortured every single day.

Letitia: You being raped in the last [?] one wanted to call you a prostitute. That you were their prostitute, and I said, "No, don't call her that, she is none, she is none of your prostitutes and you're getting paid \$2000.00 and \$3000.00 (Two Thousand to Three Thousand) dollars a month to do this to her. This is not right. This is not what America stands for. Joy, you have suffered for no reason. Have you ever broken any crimes in your life?"

(Female "Joy" Non-Consensual Human Subject): They didn't even give me the right to say, "No, Stop, Don't." They took turns at raping me while I was unconscious. They took complete; I mean I get raped almost every single day while in an unconscious state of mind.

Letitia: Have you tried going to a Rape Clinic?

(Female "Joy" Non-Consensual Human Subject): [What's that?] What can a rape clinic do? They just wait for me to get out and start raping me again. A rape clinic can't stop the perpetrators from breaking into my house because they are not breaking in; they are being let in from the inside of my home without me letting them in.

Letitia: So, are they ever told, have they ever told you how they are getting in?

(Female "Joy" Non-Consensual Human Subject): They are letting themselves in. Did you ever give them a key to get in?

(Female "Joy" Non-Consensual Human Subject): No, I didn't give them a key to get in.

Letitia: Did you ever give them a key to get in?

(Female "Joy" Non-Consensual Human Subject): No, I didn't give them a key to get in.

Letitia: So, They have equipment? They have the equipment; somebody taught them how to do this? I want to hear from one of them. I want to hear from one of them.

(1 Roger Boehm Perp): Yes, someone, yes someone taught me how to do it! You know how I'm doing it! I do it with the dials on the modem of the receiving end of her chips! You know what we can do with this equipment. Somebody taught me.

Letitia: Was it the Federal Government who taught you?

(1 Roger Boehm Perp): No, the Army!

Letitia: The Army and do you think this is right?

(1 Roger Boehm Perp): No, it is not right but I don't give a fuck because I want Joy!

Letitia: Well, aren't you married?

(Female "Joy" Non-Consensual Human Subject): Who Joy or him?

Letitia: No, I'm talking to him.

(1 Roger Boehm Perp): How do you know I'm married!?

Letitia: I don't know anything. I just ask the questions. What's your name again?

(1 Roger Boehm Perp): "Roger Boehm!"

Letitia: "Roger Boehm." B-o-o-n-e?

(1 Roger Boehm Perp): No, Boehm.

Letitia: "Boehm." And how did you know Joy?

(1 Roger Boehm Perp): I was friends with her mom and dad.

Letitia: And you were in love with her?

(1 Roger Boehm Perp): Well, Joy never even dated him. (?In Third Person Character)

Letitia: So, how did you ever put her into this program? How did she get into this program?

(1 Roger Boehm Perp): I can't tell you.

Letitia: You put her into this didn't you? She didn't select to be in this here ,did she?

(1 Roger Boehm Perp): No, I [Time Missing] [?Windilin ?—] I'm part of the Mafia.

Letitia: Really? This is heart breaking to me Larry. This is really heart breaking to me to hear that you're raping her every night for the last 24 years. It is heart breaking.

(Female "Joy" Non-Consensual Human Subject): / (1 Roger Boehm Perp): Larry Campbell is a married man.

Letitia: "Who is Larry Campbell?"

(Female "Joy" Non-Consensual Human Subject): The other perpetrator.

Letitia: How many are there are you? That is connected to her body?

(Female "Joy" Non-Consensual Human Subject): Well, eight of us can sit in a box.

Letitia: Eight can sit in a box? What box are you talking about?

(Female "Joy" Non-Consensual Human Subject): You know when they think the refrigerator talking or the stove is talking, that is someone sitting outside the box. That is why the voice is coming from a distance. It sounds like the refrigerator or the TV is talking or the stove is talking that is someone standing outside the box. Only so many people can be inside the box with the equipment.

Letitia: So, you have to go physically to the box or could you do it remotely?

(1 Roger Boehm Perp): What do you mean?

Letitia: You said the box?

(1 Roger Boehm Perp): That is where the people have to sit who are hooked up to Joy.

Letitia: Oh, so you have to meet at a certain location.

(1 Roger Boehm Perp): Yeah.

Letitia: WOW!

(1 Roger Boehm Perp): Which has to be so close to her like a cordless telephone. You have to so close to the modem.

Letitia: So, you can't be more than what, two, three miles away?

(1 Roger Boehm Perp): Yeah.

Letitia: Okay. She wants to be free. Why don't you stop?

(1 Roger Boehm Perp): Because I want her and her money that she's gonna get from being chipped. We've already embezzled money from her computer, with computer tampering.

Letitia: Embezzle money. That happened to me too. I've lost over \$100,000.00 dollars (One Hundred Thousand dollars) that I cannot account for. Is this normal practice for you to do?

(1 Roger Boehm Perp): All Perpetrators swindling money from the targeted individual.

Letitia: You think this is right?

(1 Roger Boehm Perp): No, it is not right!

Letitia: Then why do you do it? I've lost over \$100,000.00 something dollars (One Hundred Thousand Dollars). That was my money. Would you like it being done to you Larry, would you?

(1 Roger Boehm Perp): Roger or Larry? Which one on earth are you talking to?

Letitia: I'm talking to whoever just answered that question. I want to know. That's not right! I have never done anything to anybody. Nothing, why do you think you can do this to us, why?

(1 Roger Boehm Perp): Cause the Government said that we could because this is a Government Research Experiment. I made Joy a Human Subject and now I own her.

Letitia: You own her, but isn't that slavery. That's slavery, you don't own her. That's slavery.

(1 Roger Boehm Perp): I don't care!

Letitia: You don't care, wow!

(Female "Joy" Non-Consensual Human Subject): They even threatened the lives of my children, and threatened the lives of my mother, and my father before he passed away. They threaten my life practically every single day.

Letitia: Don't you want to be free of this Joy?

(Female "Joy" Non-Consensual Human Subject): Oh, I want to be free. I'm tired of all this mental anguish and the torture. They isolate me from me and my family. They said to me you better ask to go outside and if you go outside we are gonna to hurt him. They try and tell me that I have no choice but to turn gay when I am not gay. They tell me I have no choice to do the men that they want to send to me cause they want me to be their prostitute. I guess they already calling, trained on my unconscious body. Well, my body is not unconscious but my, her mind is unconscious. It is like sleep walking. I just pray to God that some day the laws will change for us targeted individuals [seek?] for and helped. I pray to God that these microchips can be surgically removed from my body in the near future.

Letitia: And it is okay for me to use anything you that give me, right? I can use anything even everything that you give me, right? You have my permission. (I have your permission?)

(Female “Joy” Non-Consensual Human Subject): Pretty much. But I never wrote to you about being in duress. I think that they tampered with some of the paperwork that I sent you.

Letitia: Okay.

(Female “Joy” Non-Consensual Human Subject): But what I faxed you that was what I really truly wrote.

Letitia: Okay, I will use that. That is if they haven’t stolen it. They’ve been stealing everything.

(Female “Joy” Non-Consensual Human Subject): Well, I know that they have embezzled some of my money and they gloat about having my money.

Letitia: Roger, Larry, this is not right! This is “Forgiveness Week.” And don’t know if Joy can forgive you right now, but I pray that she can one day because the commandment says that “We are suppose to forgive others so that God can forgive us.” I forgive you.

(1 Roger Boehm Perp): / (Ken Schaben Perp 3): What if I don’t need her forgiveness? What if I don’t care if she doesn’t forgive me?

Letitia: Oh, well, that’s cold. Who am I speaking to, Larry or Roger? That’s cold.

(Ken Schaben Perp 3): Ken Schaben, “S-c-h-a-b-e-n.”

Letitia: well, this is forgiveness week and we pray for your soul.

(Ken Schaben Perp 3): You might want to put my name down, “Craig Jensen.”

Letitia: I haven’t written any names down. But since you want to give me your names, thank you, but you’re getting paid to rape her. That’s not right. That’s prostitution.

(Craig Jensen Perp): Yeah, but the Government is paying us. This is a Government Research Experiment and the Government; we get a weekly check from our Federal Government.

Letitia: A weekly check. WOW!

(Craig Jensen Perp): Except for we get it in cash.

Letitia: Oh, so there is no traceability.

(Craig Jensen Perp): And how do you know it’s from the Government?

Letitia: So there is not traceability. But you know. So you say you own her. Did you sign any contracts to say “I own Joy?”

(Craig Jensen Perp): No, I didn't sign any contracts but I got her to sign contracts when she wasn't herself. We got papers that look legal but are illegal. She has no guardian, she has no power of attorney, she has no accountant and she no husband.

Letitia: Are those the types of people who get targeted, somebody that is single, no husband, no one to look after them?

(Female "Joy" Non-Consensual Human Subject): My husband was buried with those ear buds in him. They took my husband after I married him. They chipped him, so that they could have sex through my husband with my body.

Letitia: WOW!

(Female "Joy" Non-Consensual Human Subject): My husband was buried with chips inside of him.

Letitia: Was an autopsy done to show the chips?

(Female "Joy" Non-Consensual Human Subject): No his still in the ground with chips inside of him in Denison Iowa. The targeting started in Denison Iowa followed me down here to Omaha, Nebraska. They been breaking in and out of my home since the day I got chipped. But these people knock me unconscious and raped me before they even chipped me. With their (root beer?) they have something that they sprayed in your face to knock you unconscious.

Letitia: I'm so sorry Joy. I'm gonna do everything within my God given power to stop this.

(Female "Joy" Non-Consensual Human Subject): Thank you Litia.

Letitia: It's Letitia, but that is okay.

(Female "Joy" Non-Consensual Human Subject): Letitia... Well, God Bless You. You know I pray for you when you, well for you to be strong and for you to be heard and for people to listen to you and for you to be able to touch their hearts.

Letitia: Auhhh, thank you Joy.

(Female "Joy" Non-Consensual Human Subject): For you to be able to open up their eyes to what reality is and what us targeted individuals are being put through.

Letitia: Thank you Joy and did you get my email that I had, my text message that I prayed for you son cause you said he was going through that surgery? I did pray for him. I did pray for him.

(Female "Joy" Non-Consensual Human Subject): Thank you.

Letitia: You're welcome. It is just horrible, we, Larry, Roger we are all Americans. No one is less than American. No one, we are all Americans. Let her go!

(Roger Boehm Perp 1): What does being an American have to do with it!?

Letitia: Would you like this being done to your family member for twenty (20) something years every day, will you like this being done to your mother or you niece, or your or your, even your nephew, your cousins, would you like it being done to your family?

(Roger Boehm Perp 1): No.

Letitia: Then let her go. She's not your property. Do the right thing.

(Roger Boehm Perp 1): What about the money she's supposed to get?

Letitia: What money? How do you know she is getting money?

(Roger Boehm Perp 1): All of us perpetrators know that the targeted individuals will be receiving money.

Letitia: Really?

(Roger Boehm Perp 1): I have embezzled enough of her money.

Letitia: So you know this is going to come to an end. So what are you going to do then?

(Roger Boehm Perp 1): Get out of town, get out of Dodge.

Letitia: Really? You know you should be in jail, right for the rest of your life, right? All of you, you know you should all be in jail for the rest of your lives.

(Roger Boehm Perp 1): They just said we'll kill her tonight.

Letitia: Now you're talking about murder. WOW!

(Roger Boehm Perp 1): What did you think we done to her husband? He had lung cancer and we just let him, we kept it from her. We didn't let him tell her and we let the cancer spread on his lungs without him getting chemo or radiation. We allowed him to die. We kept him from getting treatment. He didn't even tell Joy that he had lung cancer. He tried to tell her that he had a cold.

Letitia: And you're proud of this?

(Roger Boehm Perp 1): No.

Letitia: You....

(Roger Boehm Perp 1): That is because I wanted her and she wouldn't leave him! I tried to break her up; I tried to break 'em up through other people and fighting through them. I thought with a lot of mental, a lot of marriage problems, a lot of marital problems because we argued through Joy and Bob. We had people stuck to Joy and we had people stuck to Bob and we would argue through them cause I was trying to break them up!

Letitia: So do all targeted individuals have a contract?

(Roger Boehm Perp 1): Well if they don't they will.

Letitia: WOW! I'm gonna let you go now cause I'm gonna go to [Missing Info/Mechanical Problem] and may God Bless all of you. Bye, bye Joy. Love you.

(Female "Joy" Non-Consensual Human Subject): May The Lord Be With You.

Letitia: Thank you. Bye, Bye. God Bless You.

(Female "Joy" Non-Consensual Human Subject): Bye, God Bless you too.

Follow-Up Interview with DonnaJoy

On September 17, 2012, Ms. Peters interviewed her again with her "perps". Is this what the U.S. human subject research/medical experiment is all about? To The U.S. National Leaders

(Note: Staff members; please ensure that the U.S. National Leader read this letter personally. If you are a mole, double agent, or "perp" and you delay, intercept, or do not reveal or address the entire content of this letter or the intended recipient(s) do not receive this letter in a timely fashion, you will be held accountable for your actions. I am a survivor of being a non-consensual "human subject" Even though the human subjects meet the definition of being a human subject in a medical experiment, there have been unreasonable delays in the human subjects' requests to discontinue participation in the unethical, human subject research and to receive justice now. "Whoever intentionally obstruct the proceedings before depts., agencies, and committees, obstruct this criminal investigation and/or retaliate against me because I am a victim/non-consensual human subject, you will be punished to the full extent of the applicable law in 1505 of Title 18 Obstruction of proceedings before depts., agencies & committees, 1510 Obstruction of Criminal investigations, 1513 of Title 18 Retaliating against a witness, victim or an informant, or 1514 Civil Action to restrain harassment of a victim or witness. Whoever intentionally alters, destroys,

mutilates or conceals records, or documents with the intent to impair the object's integrity or availability for use in an official proceeding will be punished to the full extent of law as defined in 1519 of Title 18 Destruction, Alteration or Falsification of records in Federal investigations and bankruptcy.”)

This document is being submitted on behalf of all non-consensual human subjects in America and Internationally whose lives have been unjustly affected. Extensive research has been done to uncover the truth of the unbelievable and the unspeakable that is happening in America and globally.

TO THE U.S. NATIONAL LEADERS:

We are requesting your immediate attention to a very important issue. Many of you are probably on the need-not-to-know list so we believe that that it is time that you are on the need-to-know the “whole truth” list.

The Issue: Men, women, and children are being used as “human guinea pigs”, without their informed consent or knowledge in America and globally. Researchers need volunteers for their research. According to the Bioethics Commission's report released December 15, 2011, it states, “There are 55,386 human subject research projects as of Fiscal Year 2010. The number of the human subject research projects is increasing each year.”

The Problem: There are countless of people in America and globally who are alleging that they are being monitored, tracked, tortured, and/or targeted with electromagnetic radiation, weapons (biological, chemical, directed-energy, electronics, or radiological) and the use of drones/satellites. They are even harassed with Counter Intelligence Program (COINTELPRO) tactics by a well-planned, well-orchestrated, well-organized, & well-connected organization with unlimited resources operating intrastate & interstate in America & Internationally. All avenues to resolve this issue has been closed to the non-consensual “human subjects”. Everything is streamlined, just like the Germans. **THE PLAN HAS BEEN STAGED FOR NO RESOLUTION EVER FOR THE NON-CONSENSUAL “HUMAN SUBJECTS”.** No justice. No due process. No investigations. Lies, deception, active denial, disinformation, threats, bribery, blackmails, intimidation by force, protocol and the technology have allowed this “well-oiled machine” to continued non-stop for 35 plus years.

We come to the following thought provoking questions: How are the researchers obtaining their “human subjects” for the projects pertaining to the State research? Federal research? Black Ops research? Are there “legitimate” informed consent forms with each human subject research projects? Has anyone ever seen these informed consent forms or the human subjects? Are human subjects being counted as “animals”?

Have the United States Federal Government and others “secretly engaged in levying an invisible war” against non-combatant citizens (men, women, and children) under the auspices of human subject research/never-ending criminal investigation/war on terror/national security? Is this genocide? Ethnic cleansing?

Have the Intelligence/DoD communities ever reported in their top-secret quarterly briefings on their counterintelligence activities any of the 30 activities in the past or currently:

1. Last year, Microwave Expert, Barrie Trower confirmed that in 1976, the United States Government advised the Western countries to keep the research “secret” in order to protect the military & industry from lawsuits. If it was known and accepted, then the industry would be bankrupt. He stated, “This is known, if we go back to between, so that the 50’, 60’s, 70’s, 80’s, if we look at that era, even the 90’s. I have documents you are welcome to copy for which the English, Australian, United States CIA, The Departments DIA, Defense Intelligence Agency with Associated Universities and the Canadian Secret Service have experimented on around five hundred thousand for over forty years consisting of the poor, psychiatric patients, pregnant women, children over the age of four, Muslims, Catholics, and Service Personnel. The Service Personnel selected were young and fit, making it an ideal epidemiologist study. Five hundred thousand (500,000) was experimented on. I have the summary of the experiments and two statements which are worth reading. The British were involved in this as well from 1986 after five hundred thousand (500,000) were experimented on. A man from Naval Surface Weapons Center in the United States said, “We can change behavior of cells, tissues, whole organisms,” in other words any part of the body. “We can have a six times higher fetal mortality rate, cause birth defects and induce malignant tumors in human cells.” From 2001-2007 there was a secret course held. Number eleven on this course the opening statement was, “Students who will be familiar with current knowledge, which is cancer, memory, brain dysfunction, and damage to the eye, skin and birth defects from radio frequency, microwave radiation.”
2. Last year, Dr. Barrie Trower conducted a 2.5 hours interview with non-consensual human subjects in Europe, which was funded by Human Subject Research Survivor Ken Rhoades. You can listen to “Barrie Trower Talks with victims of Non-Consensual Microwave and EMF Experimentation and Testing” at <http://youtu.be/09mpvscHiKI>. **TETRA** is a medical experiment until 2018, which violates International Laws because the researchers did not receive informed consent from the police, fire fighters, ambulance workers, and others in 200 nations. It has been used to make both police and demonstrators more violent. TETRA has a pulse frequency rate known to cause “tumors”. It is the Emergency Communications System. Microwave Expert, Dr. Barrie Trower stated that there are better and safer systems, but the U.S. wants its one feature: ability to listen to every person’s phone call. Many users have been diagnosed with cancers and the police are violent.
3. Teaching criminals or non-federal intelligence agents/police officers to conduct “covert entry” on our homes, autos, or cameras, this is a violation of U.S. Federal Law.
4. Teaching criminals to conduct computer tampering to steal or embezzle the human subject’s money
5. Allowing pedophiles access to human subjects’ children or their family’s children.
6. Supplying illegal drugs and alcohol to researchers/informants. The researchers/informants are using illegal or prescription drugs on the non-consensual human subjects

7. Violating International & U.S. laws pertaining to non-consensual human subjects and children in human subjects. The researchers/informants are violating U.S. and International laws by not receiving the permission of the parents/guardians to request that their children are in any human subject research/medical experiments.
8. The use of “informants”, double moles, and “perps” are being used to commit crimes by violating many laws including **domestic terrorism, treason, many Title 18 laws and even the highest supreme law of the land: The United States Constitution.**
9. Many small business owners, C.E.O.s, Presidents, government officials, and church/synagogue leaders are unaware that their employees, contractors, customers, or members are utilizing their products, services and/or establishments to commit crimes or violate the rights of the “human subjects”. Police reports or police events have been filed against their businesses or organizations without their CEO’s knowledge.

Letitia Peters states, “I have been tracked down like I was an animal; a fox in a fox hunt. I live less than 10 miles from a Fusion Center. The moment that I step my foot out the door, it is like road rage up and down the street. The autos are definitely exceeding the 25 m.p.h. speed limit as they are shooting their weapons into the house. It is bad enough that my body is being irradiated, but must everything. This is what has happened. They are utilizing the products, services, and establishments to commit or violate my rights. I usually shop at Whole Foods, Trader Joe’s, & Wal-mart and they told these people to spray “radiation” in their stores and on their products. I have been injured at every store. In another supermarket, Shop-Rite, the “perps” were targeting my lower hip bone, so bad that I could barely walk out of that store. Should I be filing an injury report for what the researchers are doing at every establishment that I have been to? I could not help someone at Christmas because the “perps” started spraying heavy concentrations of radiation on my packages and I would not accept the order. I attempted to contact Kohl’s to let them know the reasons why I returned the order, due to illegal telephone surveillance and tampering, I am not able to resolve this issue.

This is fraud. I am unable to resolve this issue because the boxes need to be tested. In the past, I have tried to get contaminated food tested to no avail. I contacted health departments, private labs and even sought the assistance of the New Jersey Governor’s office to no avail. It is because of “protocol” that no one would help me. The 3 boxes, which are heavily contaminated with a substance looks like radiation, which needs to be tested. I am tired of losing money and losing my evidence. **This house and my other immediate family’s house should be declared a crime scene, as well as, our vehicles.**

My father developed cancer and I asked the oncologist, if he could have been caused by the environment and he said yes. In my case, I know that this will be hard to comprehend, but they told the researchers/perps to spray everything, including clothes, food, products, and even mail. I have several police reports and police events because the employees at IHOP, P.F.Chang’s, and Applebee’s **intentionally** sprayed my food with unknown substance, which was most likely radiation. When I tried to contact the owners, my calls were rerouted or I never heard from anyone.

The aircrafts are leaving their flight plans to drop unknown weapons on the house. Afterwards, my skin would burn as the “unknown weapons” were penetrating my body. Now I have raised “black moles” all over my skin and scalp, which I never had. When I contacted the Federal Aviation Administration, my former employer, I was told that they have received many phone calls from people stating that aircrafts were leaving their flight plan and flying over their homes.”

10. In 2010, the unscrupulous Federal Government employees paid \$125,000 to 2 people to stop Letitia Peters from conducting a spiritual revival show and to stop the prophet Jeanne S. from saving her life. Her new neighbors came close to killing her by using lethal concentration of chemicals and electromagnetic radiation. This is how she knew that it was the Federal Government. Ms. Peters said, **“I asked her the question, “Why was this happening to me?” She responded, “They are doing it because they think that they can. Who is going to stop them?” I asked her, “Who was doing this to me?” She replied, “The Federal Government.” She agreed with my statement that this was not the entire Federal Government, but “unscrupulous Federal Government employees who are abusing their power.” The arrogance of that statement caused something in my spirit to rise up and ask Jeanne S. to give the “unscrupulous Federal Government employees” a message: “Please tell them that I am going to stop them with the help of Jesus Christ/Yeshua.”**

The prophet, Jeanne S. told her that the Feds offer her \$50,000, but she refused. She did accept the \$100,000 that was offered to her and the other person Rick C. accepted \$25, 000. She knew the truth and was a danger to them.

Countless of people were recruited to intentionally do harm to her physically, emotionally, and financially for the past 2 years. They wanted to keep their hands clean so they hired countless of people to do their dirty work including emergency room doctors, police officers, hotel employees, restaurant employees, store employees, City/State/Federal employees, people in her neighborhood, and countless of strangers.

She was literally kidnapped out of her parent’s house in handcuffs to stop her from going to the Torture Treatment Center in New York/New Jersey. Now, she will have pending lawsuits against the City of Trenton, Capital Health, and Hampton Hospital. That is only the beginning of her extensive list.

11. Feds are paying the “lead” researchers/”informants” **in cash** so that he/she can pay their other “buddy researchers” so that there is no traceability. They are receiving \$2,000 and up a month to monitor, target, torture, and harass non-combatant men. These people are not trained to be “researchers”. There is no accurate recordkeeping on how many people that the “lead” researchers/informants” are recruiting. (Note: Recently, there has been discussion about raising the minimum wage, which definitely needs to be done. Currently, the “researchers” are being paid \$2,000 a month (\$24,000 a year), which works out to be \$12.50 per hour & at \$3,000 a month (\$36, 000 a year) it works out to be \$18.75 per hour. These “researchers” do not possess a college degree; only a high school diploma. This proves that the minimum wage can go higher than \$10.00 an hour because the U.S. Federal Government is

currently doing it. If the U.S. Federal Government has been paying these “unqualified researchers” this type of money in “cash” then why can’t large businesses? Apparently, the large businesses want to be paid these wages, but they do not want to pay out of their pockets these wages, even though they can afford to do so. Has anyone thought of having two different minimum wages for small businesses & large businesses? This would be fair to the small businesses.)

12. The researchers/ informants are promised an “award” for breaking the “human subjects”.
13. One researcher/informant has bragged that he has become a millionaire from stealing or embezzling the human subjects’ money. He stated that **all** “human subjects” are being raped and their money is being stolen and embezzled. He stated that the U.S. Federal Government (Army) knows about it.
14. The researchers/informants are bragging that they are getting away with committing crimes for the past 25 years. While there are hundreds of thousands who have been wrongfully committed to mental institutions or prison, because people (judges, attorneys, juries, or prosecutors) were implanted with implants/chips, threatened, bribed or blackmailed.
15. The researchers/informants are boasting that they are not going to prison because the “Government” hired them to do a job, which is to **“break the human subjects”**. They can do anything to the human subject “within reason.” Ms. Peters states, “one of the objective of the “secret” research/medical experiment is to “break” the human subjects by discrediting us, turning our family, children, and friends against us, getting us committed to a mental institution and even prison. While the “perps” are stealing our monies, poisoning us, raping us, drugging us, torturing us and continuing to “anything within reason” to us until we “break”. They are breaking in and out of our homes and autos without showing signs of a break-in. This is called **covert entry** & only the Intelligence agencies are taught this trade, but they are teaching their “secrets” to the “perps” are being, which violates Federal Law. The “perps” were told that that they can do ANYTHING to the “human subjects” within reason. What is meant by “within reason”? **None of this is within reason. They have confessed that they committed acts, which was not authorized.** The big difference is that we are not in the military. Now, they are no longer including just chemical weapons, but also electromagnetic radiation, electronics weapons, and even mycotoxins, which is a biological weapon.

This concept of “break” a man is from the Department of Defense (DoD). This is documented on May 6, 1994, Senator John D. Rockefeller IV shared with members of the Committee on Veterans’ Affairs, he stated,

“Some of the studies that have been conducted had more questionable motives. For example, DoD now admits they conducted “Man Break” tests, **exposing soldiers to chemical weapons in order to determine how much was necessary to “break a man”**. Similarly, DoD admits that they subjected hundreds/thousands of soldiers to hallucinogens without their knowledge or consent, in an effort to determine how incapacitating those substances could be. Most Americans would agree that the use of soldiers as guinea pigs in experiments that were designed to harm them is not ethical.”

16. **Another second objective is to turn a heterosexual to become gay.** The male “perps” are raping or sodomizing the male human’s subject, even little boys. Men are raping little girls. One male “perp” who is a pedophile stated, “a butt is a butt.”

Jeff T., a “perp” states about Donna Joy, a non-consensual “human subject” for 34 years,

“This woman is a Catholic, goody two-shoes, straight laced woman who is not gay and that’s what this **game is about turning this goody two-shoes Catholic straight laced girl into a gay easy woman.**” Her son’s father and I regret what we have done to Joy. **There is a government that is behind me. We made her look crazy. We made her do — well, we made her do things that she wouldn’t have done had she not been chipped. She will never done it on her own.** Her and her husband didn’t want threesome because **I was trying to turn her gay.** All are talking into individuals are trying to be turned gay, that’s part of the project, part of the experiment among other things. **You know the rules are to ruin them in any way we can. To make them look foolish, crazy, to discredit through word and I will still discredit Joy’s word.** I will still make her look like something she is not. I will still make her look crazy no matter what the government does. **I will chip the judge, the policemen, the sheriff, the attorney, the doctor because you don’t know who I am and I’m capable of all that because there are mafia and the CIA, the military. This is a military research experiment funded by our government and I can do anything I want and the government knows it, including killing her or causing her to commit suicide.**”

17. **A third objective is to control the human subjects’ body, like a robot.** This is about having complete control over a person. This can be done by placing “human subjects” into a “hypnosis state.” It appears like the “human subjects” are themselves, but the “perps” have taken over their bodies & the “human subjects” have no recollection of what they did or said. This is being done because the “perps” are connected to the implants in their bodies. They can cause the “human subjects” to wake up, give them a headache, urinate on themselves, move their body parts, and cause pain in any part of their bodies where the implants are located. Here is the example of how the researchers/”perps” are able to control someone’s body as told to us on the September 17, 2012 episode of the International Spiritual Awakening Ministries (I.S.A.M.) Blog Talk Radio Show (www.blogtalkradio.com/isam). Here is the excerpt:

(One of the Unknown Perps Speaking through Donna Joy Plattner)

When she was in an unconscious state of mind, if you know anything about these microchips you know that we can completely take over her body like a doctor Jekyll and Mr. Hyde. I can completely take over her body. I let myself into her house at night and she willing sucks on my d**k and willingly ...

(Guest Speaker Donna Joy Plattner)

Excuse you, she doesn’t willingly. **She’s in an unconscious state of mind. Someone has taken, complete control over her body. Something you would only think you see in a sci-fi movie. Something you wouldn’t dream of happening in reality. I mean you see this in movies, when you go to a science-fiction movie. You know you watch Dr. Jekyll and Mr. Hyde on TV, but would**

never dream that in real life that someone can take complete control over your body while you're unconscious. They are moving around in your body like a hand in a glove. They can see through your eyes, and they hear through your ears, they can talk through your, through your vocal chords, but they can also take control over your, complete control over a man or a woman's body.

(One of the Unknown Perps Speaking through Donna Joy Plattner)

Now we have said too much and now you know we know too much about this equipment.

(Host Letitia Peters)

This technology is not only oppressing people, but it is also being used to destroy families. For example, the "perps" are implanting non-human subjects our family members to get them to turn against us or to help get them to commit the "human subject" to a mental institution. The "perp" bragged how he was able to implant a judge to get him to commit the "human subject" to prison. He bribed her attorney unbeknownst to her. He has regretted doing this to her, but he says that he was "following the script" to break the "human subject". Now this once law-abiding "human subject" has a prison record. They also used this technology to have her children taken away from her so that they could have her alone. Her oldest child is raising her youngest sister. **Many people are in prison for crimes that they did not really do themselves. Many people are in mental institutions because they can "hear voices", but they do not have a mental illness. They are just "chipped". They should be checked for implants/ R.F.I.D. chips in their bodies.** Mental Health Patients and Prisoners are also segments of the population, which are being experimented on without their knowledge or informed consent. Man having control over another man. Isn't that slavery?

18. **A fourth objective is to take all the non-consensual "human subjects" underground, give them electrical shocks so that they would not have any recollection of their families, being tortured, or raped so that they can become "sex slaves".** There are underground cities in various states in America & globally. The "perp" asked the question, **"Who would sign-up to be a part of this experiment to go underground?"** We replied, "No one would. (This sounds far-fetched, but we were told this by one of the main "perp".)

There are other objectives, which are documented in former Army Intelligence Officer, Julianne McKinney's 1992 publication, *Microwave Harassment and Mind Control Experimentation*, (this publication is available on the Internet to download).

Obviously, **this has been a pattern for the military, as well as, other "research institutions", if they did not have volunteers, they would decide to keep it a "secret" and then select whoever they wanted, regardless of the Laws for the past 50 plus years.**

19. The researchers are including generations of families into unethical, medical experiments, without their knowledge or informed consent, which uses electromagnetic radiation, weapons (biological, chemical, directed-energy, electronics, & radiological). They are raping men and children (one human subject

has been raped for 34 years, since the age of 16 years old. This violates International and U.S. laws.

20. Many “human subjects” have reported that drones are following them or that they are outside of their homes. Usually drones have been used for “targeted killings”. Are non-combatant U.S. citizens “targeted killings”? Are drones part of the medical experiments/research?
21. One human subject has test results that reveal that she was exposed to “mycotoxins”, which is a biological weapon. Isn’t there a global ban on using biological weapons?
22. The “perps” are using psyops on their own civilians, which violates United States Federal Law.
23. In her 2007 interview, former Army Intelligence Officer Julianne McKinney informs the host Greg Syzmanski the facts about electronics weapons and what they can do to men. Here’s the excerpt:

(Guest Julianne McKinney)

Expertise in comes with my employment in the Intelligence field. I understanding what constitutes “Surveillance,” I’m capable of immediately “Spotting a Surveillance,” and I can see as in the case of “Gangstalking” a subject which you have address on prior occasions, I can see those who I label as “Covert Wantables” bumbling and stumbling through what they think are covert activities and find it really rather amusing if it were not so perverted in the ultimate objective. I’m not certain what more I can add; I do have experience with these weapon systems. I have sufficient opportunities over the past many years to observe the progressive spread of these harassment operations and I’m talking specifically about electronic weapon systems.

(0:07:50.5) (Host Greg Syzmanski)

Well you’ve been a voice; I mean a strong voice of warning people of these systems in at least this past ten (10) years regarding the installation of specialized electronic equipment and utilities. **What are these electronics and what are their capabilities?**

(Guest Julianne McKinney)

Their capability, generally are to inflict pain in a highly focused fashion and to alter mental states when you have the frequency aimed at your brain, your mental function tend to alter. In amplified form their sufficient the frequencies have the capacity to kill that’s why, that is one reason why the Department of Defense (DOD) refers to them as “Less than Lethal” instead of “Non-Lethal” Weapons. As the matter fact the Department of Defense has gone so far as to eliminate them to removed them from the category of even less than lethal weapons and bury them under the category of “Electronics Weapons” to make them a little bit blacker.

The researchers/perps are not qualified to be researchers, but they possess weapons, which inflict pain and can kill. Who gave these weapons to them? **Why do civilians have these lethal weapons in their possessions? Are these weapons part of the medical experiments?**

Effective laws should be developed for drones, satellites, less than lethal, non-lethal weapons vs. lethal weapons, and biological/chemical/directed-energy/electronics/radiological weapons.

24. What about the human subjects' mental state? This is part of the "game" in order to isolate and control the "human subjects" by discrediting them and getting them declared to have a mental illness. Many of the "human subjects" who are claiming to hear "voices" are hearing voices. Donna Joy's story is posted at <http://www.LetitiaPeters.weebly.com>. The "perps" are connected to her through her "implants", which allows them to hear everyone who she is talking to, as well as, others can hear the "perps", if they wanted to express themselves like they did to Ms. Peters. They tried to get Donna Joy committed, but their attempt failed. The judge dismissed her case, after a 3-day evaluation. You know how a speaker is connected; it is based on the same concept. The speaker must be connected to a source, which is close by.

Many "human subjects" have been wrongfully diagnosed with a mental illness. For many, they will require surgery to remove the implants that were illegally implanted in their bodies without their knowledge or consent so that no one will believe them and the researchers can continue to do the unethical, medical experiment on them.

It is documented in official Federal Government medical records/documents that the Federal Government scientists diagnosed many non-consensual "human subjects" with "neurosis" or "paranoid schizophrenic" when they stated that they were being experimented on by them.

For example, this was documented in the case of the late Elmer Allen.

The sad part about Elmer Allen's story is that nobody believed him. He went to his doctor and told him, "I think I've been injected with something." His doctor diagnosed him as a paranoid schizophrenic at the same time that he was conversing with the atomic energy scientists in Argon National Lab to provide them with tissue samples. Elmer Allen was not only used in 1947 when he was injected with this radioactive isotope, **but he continued to be used as a guinea pig for the rest of his life**. When Elmer Allen's daughter, Elmerine was interviewed, she told the story of when she left for college, her father would tell her watch out, "Don't let the U.S. Government guinea-pig you." And they always thought that Elmer Allen had some kind of, well, Elmer was kind of quirky, and he had this delusion that the Government experimented on him.

In the 1970's, a **second generation of atomic scientists rediscovered this experiment**. So they wanted to dig up all the people who were dead, who had been injected with plutonium, and they also wanted to bring whoever survived them back into the lab for further studies. Elmer Allen was one of those people who was still alive.

AMY GOODMAN: Under what pretext since he didn't know, supposedly, that he was a U.S. Government guinea pig?

EILEEN WELSOME: They told Elmer, and this is all documented in the medical records, that they knew he had a very serious cancer and they wanted to know how he had lived so long.

Eileen Welsome, Pulitzer Prize winning reporter and author of *The Plutonium Files: America's Secret Medical Experiments in the Cold War* said, "Basically, they confirmed that thousands and thousands of experiments had been done on U.S. Citizens. That the victims were the most vulnerable people in our society: the young, the disenfranchised, the poor, people of color, people who did not know enough to ask questions. In other words, the subjects were not doctor's children or friends of their doctors; they were people who were vulnerable. The biggest revelation for me was to see how cruel and inhuman these very educated doctors were toward their patients."

Like Elmer Allen, many non-consensual "human subject" have been labeled as "crazy", "delusional" or been diagnosed with a "mental illness". It was only the Atomic Energy Scientists in Elmer Allen's case, but now the playing field has expanded exponentially.

Now it includes the following, but it is not limited to: police officers, psychiatrists, judges, physicians, federal intelligence agents, family members, friends, and associates are being used to discredit the non-consensual "human subjects".

Many "human subjects" have been declared with the mental illness of schizophrenia in order to discredit them.

25. Under the [United States Attorney General's Guidelines](#), the FBI is already required to disclose its informants' crimes to federal prosecutors. Has the FBI disclose any of the crimes that their informants are committing against the non-consensual "human subjects"?
26. In the Oct. 2, 2012 article "*Research says St. Louis Residents Affected by Secret Military Experiments*" reveals that "secret" research was conducted on non-consensual "human subject" during the Cold War era. The article said "Claims have surfaced that during the 1950s and the 1960s the United States military conducted secret experiments on St. Louis residents, which may have exposed them to radioactive compounds." Professor Lisa Martino-Taylor, a sociologist at St. Louis Community College, has spent years investigating the Army-conducted experiments and she finally made her research public today.

Her research shows the **government sprayed zinc cadmium sulfide over thousands of St. Louis residents without their knowledge**. The question is whether or not the Army added radioactive material to that mixture as well.

Martino-Taylor's answer is **yes**.

"The study was secretive for a reason," she said. "They didn't have volunteers stepping up and saying yeah, I'll breathe zinc cadmium sulfide with radioactive particles."

Senator Blunt believes it's disgraceful to test anything on anyone without their knowledge."

Professor Lisa Martino-Taylor's report, *"The Manhattan-Rochester Coalition, Research on the Health Effects of Radioactive Materials, & Materials, & Tests on Vulnerable Populations without Consent in St. Louis", 1945-1970* states, "When later asked about the deception, one Army official explained that **"the army didn't really lie. They just didn't tell the whole truth"** (Cole, L., 1994: 5). Thus, officials in the tight-knit group who knew about the plan, including military officials, defense industry insiders, and select members of the scientific establishment, participated in a deception of local officials and the public about aerosol studies that targeted non-suspecting civilians. As a result, **the public did not know to hold military officials to the Army's own protocol for "human subject" testing, as promulgated by the Army Chief of Staff in 1952** (U.S. House, 1977: 178)".

27. The Army lied in 1994 when Former President Clinton asked them if they were conducting experiments on involuntary or unwitting subjects. Their response was NO. Former Army Intelligence Officer Julianne McKinney was and still aware that this is happening to her and countless of others in America and globally. We have irrefutable proof that both the Army and CIA are conducting experiments on involuntary or unwitting subjects. The name of the experiment: Pandora. It is an Army project in Nebraska. Can anyone obtain the informed consent form that Donna Joy signed to be included in the Pandora's experiment, as well as, her parental informed consent form, which she signed to give her children's permission to be in the medical experiment?
28. In Former Army Intelligence Officer Julianne McKinney's 1992 publication, "Microwave Harassment and Mind-Control Experimentation" several research/medical experiments are also mentioned, which appears to be unethical as well in this report: Pandora, Pavlovian Experiment, MKULTRA, and Project Slammer. Twenty years later, "human subjects" have mentioned that they are in the Pandora and MKULTRA research, as well as, Star Wars. Are there "legitimate" informed consent forms for these human subject research projects? Has non-consensual "human subjects" been declared as animals when they should be declared as "human subjects"?
29. **Many non-consensual human subjects spoke at the Bioethics Commission's meeting in March and May 2011. Did the media hear about the public comments, which were made by the non-consensual human subjects at the March and May 2011 public sessions?** There were no mention of them. Now, even the Bioethics Commission's website, bioethics.gov does not contain the video. One newspaper, America Free Press did the story about them because every journalist left the room before they gave their testimonies.
30. **The Targeted Individuals/TIs meet the definition of being a human subject in a medical experiment/ research.** They have been "classified" as "consensual human subjects" without our consent.

According to U.S. and International Laws, as "human subjects", we have the right to "opt out" at any time without prejudice. Many non-consensual human

subjects have sent their opt out forms to the Department of Health and Human Services in March/April 2011. It was not until one human subject, Ms. Peters asked her Congressional representatives to act on her behalf. Finally on June 28, 2012, she received a letter from H.H.S. requesting information. Since then, Ms. Peters has been gathering the information to answer their questions. Now, she has answers to their questions and much more. It is now longer just a United States issue, but now it is also an International issue with the serious crimes of violations of medical ethics, violations of research ethics, crimes against humanity, crimes against peace, war crimes, crime of genocide, mass murder under the auspices of a human subject research/war on terror/(never-ending) criminal investigation/national security and possible ethnic cleansing.

Lies and Deception

Everything is streamlined like the Germans. They even became very good at lies and deception. Here are 8 possible lies and deception that are being used to keep people from believing the non-consensual human subjects and others from conducting an inquiry or a full-fledged investigation:

- a. Involved in a “secret” human subject research/medical experiment;
- b. Involved in a (never-ending)criminal investigation, but due to strict protocol they cannot divulge what they have done or is being investigated for;
- c. People should not believe anything that they are saying because they have been labeled with a mental illness, when in reality it is not true. The “perps” also refer to them as “crazy” or delusional. This is discussed in detail in number 21 above.
- d. Make claims that “such-and-such”(i.e. FBI) protocol keeps them from talking about it or anyone informed exactly what they have done or is being investigated for;
- e. Make claims that it involves national security, but due to strict protocol they cannot divulge what they have done or is being investigated for;
- f. Make claims that it involves war on terror, but due to strict protocol they cannot divulge what they have done or is being investigated for;
- g. Make claims that the person is a racist; and
- h. Other lies and (unjustifiable, explicit or implicit) deception are being used to obtain the cooperation of people to “conduct the daily experiments” of monitoring, targeting, torturing, and tracking the human subjects with electromagnetic radiation, biological/chemical/directed-energy/electronics/radiological weapons. This is a violation of ethics

The non-consensual human subjects are just like the men in the Tuskegee Syphilis Experiment or the Guatemala experiment, which the Bioethics Commission declared as unethical.

In Summary:

Researchers are bound to a code of ethics. Since WWII, each set of regulations and internationally adopted principles concerning research with human subjects consider the following issues to be of tantamount concern:

- Human subjects must voluntarily consent to research and be allowed to discontinue participation at any time.
- Research involving human subjects must be valuable to society and provide a reasonably expected benefit proportionate to the burden requested of the research participant.
- Research participants must be protected and safe. No research is more valuable than human well-being and human life.
- Researchers must avoid harm, injury, and death of research subjects and discontinue research that might cause harm, injury, or death.
- Research must be conducted by responsible and qualified researchers.
- No population of people can be excluded from research or unfairly burdened unless there is an overwhelming reason to do so.

Many of the principles identified above are being violated in the current medical experiments/human subject research. This includes:

- The human subjects have never voluntarily given their informed consent to be in any human subject research or medical experiment.
- Even though the human subjects meet the definition of being human subjects in medical experiments, there have been unreasonable delays in the human subjects' request to discontinue participation in the unethical, human subject research. This violates U.S. and International laws.
- The research is no longer protecting the human subjects from physical or psychological harm (including loss of dignity, loss of autonomy, and loss of self-esteem).
- The research is no longer protecting the human subjects from privacy and confidentiality
- The research is no longer protecting the human subjects against unjustifiable deception.
- The research is being conducted by irresponsible and unqualified researchers who have not been properly trained to protect the well-being and the human life of the human subjects.
- The research has unfairly burdened on Moors, African-Americans or people of color to be experimented as "human guinea pigs" on without their informed consent or knowledge. During the past 100 years, the U.S. Federal Government has been experimenting on them and a population of people has been excluded from research. Presently, there is a majority of women in the unethical, medical experiment subjects.

We demand that all agents, city/county/state & federal employees, city/county/state/& federal officials, employees, officers, informers (in fact not presumption), contractors, sub-contractors, members, and representatives stand under and to enforce United States and International Laws

enforce the United States Constitution, Natural Laws/International Laws, the Nuremberg Treaty and all applicable Laws.

We cannot afford any more delays and interceptions from “informants” working in the City/County/State & Federal. Many human subjects are willing to file criminal/civil lawsuits against businesses and employees, even Federal employees? Will the Federal Government represent the unscrupulous Federal Government employees if they are sued personally while working in the capacity of their positions?

Due to lack of accountability, lack of oversight, and unlimited resources have caused the Intelligence Community, Dept. of Defense, and others to create this almost “perfect” well-planned, well-orchestrated, well-organized, & well-connected organization with unlimited resources operating intrastate & interstate in America & Internationally. It is a “well-oiled machine” that has been non-stop for 35 plus years. They got away with murder when they were investigated in the 1970’s and they were only reprimanded. No one was prosecuted. Basically nothing changed. Now, they have this attitude, “We can do this because we think that we can. Who is going to stop them?”

The plan for the non-consensual “human subjects” is 3-fold:

- They have to control every aspect of the lives of the “human subjects” by any means possible. They must “break” them within reason. They have to control the lives of the “human subjects” and destroy it. They can control who they talk to, meet, date, marry, or interact with. They can even control their bodies, minds, and/or souls.
- They are “human subjects” for life. They are not seen as men, but as being “disposables”. Once someone has been “selected” intentionally/randomly in a research/medical experiment, there is NO WAY OUT, until he/she commits suicide or die! Once one family member is selected, then the entire family bloodline is selected. It becomes “generational”. The plan has been staged for no resolution ever for the non-consensual “human subjects”. No justice. No investigations. No due process.
- The public must never find out the “whole truth” of what they are really doing to the “human subjects” and the future plans that they have for the “human subjects”.

The researchers have been getting away with the “secret”, medical experiments because of lies, deception, active denial, threats, bribery, disinformation, blackmail, intimidation by force, the laws (allow the “loopholes” to continue) and the use of technology. They even used the need-to-know concept. They also use “protocol”, abuses of power, and abuses of laws.

The “informants” has been the Achilles’ heel to the human subjects because they are the gatekeepers whose job is to keep the truth from being revealed. They are planted “everywhere” to ensure that there is no justice, no resolution, or no investigations for the human subjects ever so that the Government officials or public will never find out the “whole truth”. Many are even staff members. They are also conducting the “daily experiments” on the human subjects, as well as, conducting the COINTELPRO tactics.

We applaud the efforts that America has done for other nations who are in need of help against human rights violators. It is time that America took care of Americans to address human rights violators right in our backyard.

Ms. Peters states, "I love America, but does America love me. I am a peaceful, loving, and non-combatant woman whose country has engaged in levying an invisible war against for no other reason than **"they think that they can"**. Since September 2009, I have endured the most horrific persecution of my life. I did not think that people could be so malicious. No one had the right to intrude into our lives to try to ruin it. Nor did they have the right to give out private information to countless of people in America and globally down to the third generation.

Have people forgotten the Carnal Rule: **Do Unto Others As You Would Have Them Do To You?**

Many men in America and globally have endured horrific persecutions. We did not willingly volunteer or give our informed consent to be in any research or medical experiments. **We want to opt-out of these unethical, medical experiments according to United States and International Laws immediately.**

Many lives are at stake. The "human subjects" are being targeted very hard. We are requesting your immediate attention.

It is time for the "whole truth" to be revealed. Justice and truth must be revealed fully now in order to reconciliation to occur. We want to opt-out now. We want these medical experiments to be suspended immediately. The Fusion Centers should be suspended. There should be a moratorium on all human subject research in America and globally immediately. We demand that the unethical medical experiments/research should be terminate/suspended immediately as per United States and International Laws.

We demand that there are tribunals in America and Internationally. We demand restitutions, as well as, others remedies, which are identified in the Affidavit of Facts: Disclaimer. (Note: The Affidavit of Facts: Disclaimer is a document, which consists of 50 Facts, my firsthand experience, and remedies/reliefs, but I am experiencing constant computer interruptions and the computer is causing severe pain in my fingers every time that I am using it.)

The stage has been set for no resolution ever for non-consensual "human subjects". No investigations. No due process. No justice. The non-consensual "human subjects" are no longer considered "men". They are considered slaves with no rights. The "researcher institutions" have exceeded their charter. The crimes are numerous, which are in violation of United States and International Laws.

There are abuses of powers, abuses of laws, waste, fraud, violations of medical ethics, research ethics, crimes against humanity, crimes against peace, war crimes, crime of genocide, violation of many of Title 18, violation of the United States Constitution, violation of due process, slavery, **domestic terrorism** and violations of many U.S. and International Laws including engaging in levying war on citizens, which is **TREASON**.

All agents including the Federal agencies, state agencies, judges, Congressional representatives and their contractors are to enforce to the extent of securing all guarantees of life, liberty, and property as provided by the supreme law of the land, the Constitution of the United States. We demand that they obey the oath that they have taken to enforce, protect, and preserve the Constitution of the United States.

We met the definition of being victims of crimes. Crime exists because we have been directly and proximately harmed (physically, emotionally, or financially), as a result, of the commission of federal/state offenses.

We have been deprived of equal protection of the 14th Amendment. Its [Equal Protection Clause](#) requires each state to provide **equal protection** under the law to **all people** within its [jurisdiction](#).

We have been deprived of due process. According to the 14th Amendment, the [due process clause](#) prohibits state and local governments from depriving persons of life, liberty, or property without certain steps being taken to ensure fairness. As stated in [Slaughter-House Cases, 16 Wall. 36, 67-72 \(1873\)](#); [Strauder v. West Virginia, 100 U. S. 303, 307-308 \(1880\)](#):

“It ordains that no State shall deprive any person of life, liberty, or property, without due process of law, or deny to any person within its jurisdiction the equal protection of the laws. What is this but declaring that the law in the States shall be the same for the black as for the white; that all persons, whether colored or white, shall stand equal before the laws of the States, and, in regard to the colored race, for whose protection the amendment was primarily designed, that no discrimination shall be made against them by law because of their color? The words of the amendment, it is true, are prohibitory, but they contain a necessary implication of a positive immunity, or right, most valuable to the colored race,—the right to exemption from unfriendly legislation against them distinctively as colored,—exemption from legal discriminations, implying inferiority in civil society, lessening the security of their enjoyment of the rights which others enjoy, and discriminations which are steps towards reducing them to the condition of a subject race.”

Protection and enforcement of crime victims’ rights at State and Federal levels are essential. Commonly affirmed Victims’ Rights include:

- The right to protection from intimidation and harm.
- The right to be informed concerning the criminal justice process.
- The right to reparations.
- The right to preservation of property and employment.
- The right to due process in criminal court proceedings.
- The right to be treated with dignity and compassion.
- The right to counsel.

As crime victims, our rights under 18 United States Code, Section 3771 include:

- The right to be reasonably protected from the accused;
- The right to reasonable, accurate, and timely notice of any public court proceeding, involving the crime or of any release or escape of the accused;
- The right not to be excluded from any such public court proceeding, unless the court, after reviewing clear and convincing evidence, determines that testimony by the victim would be materially altered if the victim heard other testimony at that proceeding;
- The right to be reasonably heard at any public proceeding involving the release, plea, sentencing, or any parole proceeding;
- The right to full and timely restitution as provided in law;
- **The right to proceedings free from unreasonable delay;**
- The right to be treated with fairness and with respect for the victim's dignity and privacy.

Many of our crime victim's rights have been and still are being violated. We demand justice. We are experiencing damages, irreplaceable damages because the laws are not being enforced. We are entitled to these rights and demand that we received them now. The unethical medical experiment/research continues to operate while violating the laws, including the supreme law, the United States Constitution.

The crimes of interest to the International community are mass murder under the auspices of human subject research/war on terror/national security/never ending criminal investigation, crime of genocide, war crimes, crimes against humanity, and crimes against peace.

We demand no more unreasonable delays. We demand that Congress constitute a tribunal in America, which they can do under the U.S. Constitution and that an International tribunal is held since International crimes were committed.

Eileen Welsome, Pulitzer Prize winning reporter and author of *The Plutonium Files: America's Secret Medical Experiments in the Cold War* said, "I think that the way to safeguard yourself, you as a patient or your loved ones as patients, is by asking questions. And the other way to safeguard — the other way to prevent these things from happening again is to make sure that what we do is open and available to the public. Because openness is a disinfectant and it keeps these kinds of malignant, unethical experiments from happening."

We, the people are demanding justice now in America and Internationally immediately.

It is time for the U.S. Federal Government to be open once again.

Let’s finish what Former Senator John Glenn started.

Let’s finish what Former President William Clinton started.

Let’s reform everything that is corrupted, reckless, and ignorant.
