Laws are Ratified & Reform Occurs for America not Keeping Her Promise to Liberate the Slaves Forever as stated in the Emancipation Proclamation

The 150th anniversary of the Emancipation Proclamation occurred on January 1, 2013, during the Year of the Jubilee and America has not kept her promise that the slaves shall be forever free. Pastor Dr. Paul de Vries wrote in his December 31, 2012 article *Grand Jubilee 2013: Biblical Emancipation*, “We are set to celebrate the Grand Jubilee of the Emancipation Proclamation, and yet millions of our people unjustly languish from the **horrific shackles of inadequate education-and hundreds of thousands, and their families, tragically suffer through the additional shackles of incarceration.** However, two momentous themes ring out in the Emancipation Proclamation. **First, as of January 1, 1863, people held as slaves “shall be then, thenceforth, and forever free.” Second, all government authorities “will recognize and maintain the freedom of such persons, and will do no acts to repress such persons in any efforts they may make for their actual freedom.”** Wonderful words! Now 150 years later, it is high time to help release our shackled brothers and sisters “...for their actual freedom.” America has not kept her promise and we should pray that reform occurs and that various laws are ratified.

Many descendants of former slaves are still being repressed. The word “slavery” is no longer being used, but what is being done to the former slaves meets the regulatory definition of slavery, which violates the United States Constitution and International Laws. One example is the intentionally selection of descendants of former slaves who are used in “secret” human subject research projects, without their informed consent and knowledge. For the past 100 years, researchers have intentionally experimented on descendants of slaves and they have never stopped experimenting on them.

Here’s the story of the late Elmer Allen:

The sad part about Elmer Allen's story is that nobody believed him. He went to his doctor and told him, "I think I've been injected with something." **His doctor diagnosed him as a paranoid schizophrenic at the same time that he was conversing with the atomic energy scientists** in Argon National Lab to provide them with tissue samples. Elmer Allen was not only used in 1947 when he was injected with this radioactive isotope, **but he continued to be used as a guinea pig for the rest of his life.** When Elmer Allen's daughter, Elmerine was interviewed, she told the story of when she left for college, her father would tell her watch out, "**Don't let the U.S. government guinea-pig you.**" And they always thought that Elmer Allen had some kind of, well, Elmer was kind of quirky, and he had this delusion that the government experimented on him.

In the 1970's, a **second generation of atomic scientists rediscovered this experiment.** So they wanted to dig up all the people who were dead, who had been injected with plutonium, and they also wanted to bring whoever survived them back into the lab for further studies. Elmer Allen was one of those people who was still alive.

AMY GOODMAN: Under what pretext since he didn't know, supposedly, that he was a U.S. government guinea pig?
EILEEN WELSON: They told Elmer, and this is all documented in the medical records, that they knew he had a very serious cancer and they wanted to know how he had lived so long.

Eileen Welsome, Pulitzer Prize winning reporter and author of *The Plutonium Files: America's Secret Medical Experiments in the Cold War* said, "Basically, they confirmed that thousands and thousands of experiments had been done on U.S. Citizens. **That the victims were the most vulnerable people in our society: the young, the disenfranchised, the poor, people of color, people who did not know enough to ask questions. In other words, the subjects were not doctor's children or friends of their doctors; they were people who were vulnerable.** The biggest revelation for me was to see how cruel and inhuman these very educated doctors were toward their patients."

Also, in her book, **Deadly Monopolies**, medical ethicist Dr. Harriett Washington states that the scourge has spread beyond racial minorities. **Since the 1980s, approximately 20 U.S. research projects have won legal waivers allowing them to bypass any form of informed consent.** In 2011, drug giant Pfizer **paid \$75 million** to settle claims that children in Kano state, Nigeria, were injured or killed by non-consensual administration of its experimental meningitis drug Trovan. The U.S. Common Rule is the only law that allows for waiver of informed consent. Children who are wards of the state should not be experimented on, but they can according to the U.S. Common Rule. **As of FY 2010, there were 55, 836 human subject research projects & that number is increasing even though the laws have not been ratified to close the “loopholes” in order to “protect” the welfare & safety of human subjects since 1997. Congress, researchers, & the Federal Gov’t are morally responsible for not holding the military, the intelligence agencies, & private industry accountable.**

Researchers?/Investigators are bound by a code of ethics that **includes the following protections for subjects and this includes everyone who are recruited the Key Student Personnel and Informants/Perpetrators:**

- **Protected from physical or psychological harm (including loss of dignity, loss of autonomy, and loss of self-esteem)**
- **Protection of privacy and confidentiality**
- **Protection against unjustifiable deception**

- **Subjects have the right to refuse to participate without penalty if they wish.**
