Re: Urgent Action for Affidavit of Facts Disclaimer for “Unwitting” or Involuntary “Human Subjects” in NSA’s PRISM Research

Sir:

We have become knowledgeable of key information and in the process of removing ourselves from abuses and rights violations part of which is enclosed in the Affidavit of Facts: Disclaimer for the NSA’s PRISM Research contains the abuses and rights violations, my first-hand experience, and remedies/reliefs, as well as, my Opt-Out form for the NSA’s PRISM Research.

The Problem: There are countless of people in America and globally that are monitored, tracked, tortured, and targeted with electromagnetic radiation, weapons (biological, chemical, directed-energy, electronics, or radiological), and even harass with Counter Intelligence Program (COINTELPRO) tactics by a well-planned, well-orchestrated, well-organized, & well-connected organization with unlimited resources operating intrastate & interstate in America & Internationally. All avenues to resolve this issue has been closed to the non-consensual “human subjects”.
