#### **“The Exposure of America’s Silent, Invisible Nightmare (S.I.N.)” Series**

##### **(Part 2 of the 3 Part Series)**

In part 2, we will examine Former United States Federal Government Electronics Engineer turned Activist Letitia Peters’ research and what it revealed. In 2010, she was slowly dying because of the radiation & high dosage of chemicals coming from her “new” neighbors. She was looking for answers to my questions. **How were 3 generations of my family members “selected” to be “guinea pigs” for the rest of their lives in the human subject research/medical experiment? #### **PRISM is not the Only Unethical Research: Research Reveals Serious Crimes of Domestic and International Concerns**

In Letitia Peters’ own words: “Why are we being spied on? We are law-abiding. We have not done anything to anyone.

I wanted to know how this was possible. Here I was: I have a Bachelor of Science in Electrical Engineering from Rutgers University and I have 16 years of experience working as a test engineer, program manager managing 3 acquisition programs worth close to \$100 million, and a project scheduler at the Federal Aviation Administration (F.A.A.) in Pomona, NJ and Washington, DC. I have no criminal record. I do not smoke. I used to drink “socially”, but I stopped that completely. I am hard working. I love children. I love giving back to the community. I love tutoring children especially in math, which I have been doing since high school. I was a tutor while I was working for the F.A.A. in Washington, D.C., which I miss doing. I volunteered to be a tutor at Perfecting Faith Church, but I could not keep my commit due to the

heavy persecutions. More importantly, I did not want to expose the children to any chemicals or radiation. Now, I look forward to the possibility of tutoring children this summer.

I am convinced that many people do not know the “whole” truth. I have heard that he’s the President and he has to know. I explained to them these three important key factors.

- First, it is impossible for President Obama to know the interworking of every detail of every “classified” or “secret” human subject research projects that he signs off of.
- Second, humbly speaking, I was a program manager for some high-profile acquisition programs and I would give high-level Power Point briefings to Federal Aviation Administration Senior Managers. They did not want to know everything. We presented to them what they wanted and nothing else. It was based on the need-to-know concept. We would only tell them, what we think that they should know. If they did not ask, then we did not tell. This is standard philosophy in the Federal Government: the need-to-know concept.
- Third, it is unconceivable, but are there moles/double agents/”perps” who are “secretly” working to keep certain “privy” information like my 10 page letter faxed, which was faxed to President Obama in 2010 based on the need-to-know concept? I faxed it from 3 locations: Staples in Pennsylvania, Trenton Public Library in New Jersey, and Congressman Holt’s office in New Jersey. I should have received a response, but I never did. One time I faxed a letter to the White House and I looked on my fax machine and apparently, it was rerouted to a 703 area code, which is in Virginia. Why my information was rerouted & was this the case for the other three locations.

The truth of the matter is that NSA Whistle Blower Edward Snowden is the messenger who must be destroyed at all cost now, because he did not use the “normal channels.” This revelation only came to light because he did not tell anyone. In addition, he was “one of them” and he was never on anyone’s radar like I have been heavily since December 2010 when I accidentally found out it was the “unscrupulous” Federal Government employees.

**How long have I been on the Federal Government’s radar?** I will not discuss the details here, but based on my research and what Jeanne S. revealed to me, apparently, it has been a long time, unbeknownst to me. Between 2004-2005, when the decision was made to intentionally select me to be in an unethical, unconstitutional research as retaliation for revealing about the toxic mold problem in the Federal buildings in Washington, DC. and that is a violation of Title 18. Since they were only able to delay my disability by seven months, now they have resorted in other ways to take and steal my money by using the Internal Revenue Service and the researchers/investigators/informants/perps. This includes obstruction of justice by stealing my records and changing documentation. They are using my father and he keeps bringing up what I did in DC. That is another clue that me and three generations of my family were intentionally selected to be in this unethical, unconstitutional research without our informed consent because of Jealousy, Personal Vendetta, Retaliation, and Racism. Several Helene Fuld Hospital personnel asked my mother, What was I on disability for? I asked her not to answer that question because they did not need to know and furthermore it was none of their business. She replied that she did not know which she didn’t. People have been scavenging through my personal files at my parent’s house taking the information and then returning it. When are jealousy, personal vendetta, retaliation, and racism criteria for selecting someone to be in a research? They did not exempt me on my compromised immune system, which they should have. **I am considering this ATTEMPTED MURDER. All agents who have not done anything before NOW to opt us out of this research will be held for your actions and your lack of actions. I went above and below the protocol list and my requests were completely ignored. God will judge your sin.**

### **What would you do?**

If someone told you that you and your family were going to be in this program for the rest of your life and that once you are in there is **NO WAY OUT!** There is nothing that you can do. You know that you have been a law-abiding citizen and did not deserve this.

## **Whistleblower Retaliation**

If this was a legitimate human subject research, why is it a “secret”? Why is my evidence sabotaged, deleted, or stolen? That was my first clue. That is what psychopaths or sociopaths do so that the truth is never discovered.

I am over 21 years old and have free will, which means I can pick and choose what I want to do and what I don’t want to do. I do not need anyone to do it for me.

How dare the Federal Government, its agents, & contractors intrude into every area of my life? Our lives?

There is always something that can do done. **God would never allow for a problem to exist, without having a solution. The problem here is not no one has investigated for a solution.**

**I guess that is where I come in because I have a gift for “research” and this was confirmed by Apostle McKinney.**

I am already on disability with all of my health ailments and trying to get well so that I can become a productive citizen and a pillar in the community again. Why would I volunteer to be in a research, which involves any type of electromagnetic radiation, chemicals, lasers, or poisoning, which would maim or even kill me? This daily torture has worsened my already compromised body. I am only alive because of the grace and mercy of God. I give Him all the glory.

I know how the Federal Government works. I was an insider myself until I came across one person and it had to be a female who did not like me.

There are laws, regulations, and statutes that must be enforced and obeyed. Why aren’t they?

This is not a third world country. This is the United States of America where everyone is entitled to life, liberty and security of person, freedom from slavery and servitude, freedom from torture, or cruel, inhuman or degrading treatment or punishment, equality before the law, not being subjected to arbitrary arrest, detention, or exile, freedom of movement and residence, nationality, the right to marriage and to found a family, freedom of thought, conscience and religion, peaceful assembly and association, work, health, and education. ## **The Truth Revealed by an Unlikely Source**

I was looking for answers to my questions. **How were 3 generations of my family members “selected” to be “guinea pigs” for the rest of their lives in the human subject research/medical experiment? What were the “selection” criteria? How could this happen in America in the 21<sup>st</sup> century? Can they really do this to us without our informed consent & knowledge? How are they getting away with it? Why aren’t investigations being conducted, these “perps” going to jail for their crimes, or the so-called research projects terminated for wrongdoing or noncompliance?**

I was researching day and night for answers to my questions, despite the unbelievable torturing that I experienced and am still experiencing. I have constant computer & network interruptions, computer “crashes”, 24/7 monitoring, tracking, harassing, targeting and torturing with radiation, lasers, electronic weapons, generators, lethal concentrations of chemicals & even biological weapons. I am being exposed to daily poisonings being intentionally sprayed on our food, possessions, in our homes and autos. All of this is being done by neighbors, family members, friends and mostly complete strangers. I was being hit so hard in 2010 that I did not think that I was going to see 2011. I suffered in silence and I cried out to Jesus/Yeshua to protect me & my family every day several times a day.

By the end of 2010, I felt death knocking at my door. I even dreamed about my funeral and I saw the “babies” crying that their “Aunt Tish” was never going to be there for them. I was looking for answers to why our “new neighbors” were stalking me from room to room with “whatever weapon that they had to target my head”. I was sleep deprived. I developed deep, dark raccoon circles, which I never had. My eyes would become severely dry & puffy. My face would break out in hives and rashes. My skin would turn very “dark”. My face would swell up, because my head would pulsate and my eye glasses would leave dark marks on my nose ridge after I wore them. I suffered from migraines, which would last for hours or days. Due to the intense trauma to my body, my weight would fluctuate daily. I could gain 5-15 pounds daily and overnight due to the “water retention” because my body was “protecting itself”. Other parts of my body would also swell up, including my stomach, feet, ankles, legs, and even my fingers. My vision became “blurry”. All of this was happening on top of my many health ailments due to an already compromised body left by toxic mold exposure in the Federal Government buildings in Washington, DC.

### **I knew that I was going to die unless I had a divine intervention.**

One night it was so unbearable that I cried out to Jesus/Yeshua. I was in the attic trying to seek refuge from their weaponry behind a three drawer steel cabinet. I could hear something walking up their attic stairs following me. I did not know what to do to protect my brain. I wrapped my head in heavy duty aluminum foil on top of my headscarf based on what I was told about “protecting myself.” I started crying and I cried out to Jesus/Yeshua to protect me. I felt God’s hand protecting me from that “energy”. It was like a barrier was created. I drifted off to sleep and for the first time, I got a good night’s sleep. I woke up and for the first time I did not have a migraine and no raccoon eyes. The aluminum foil was still intact. It was not wrinkled. There were no holes and it still looked new. I thank Him for answering my cry for help. After that, I no longer wrapped my head in aluminum foil. I depended on Him for my protection.

### **I continued to search for answers to my questions.**

Queen, a fellow “human subject” and mentor had told me about this person who could help any “Targeted Individual/TI” who was going through this ordeal. Targeted Individual/TI is the name coined by those who have been targeted by the Federal Government and their contractors.

They were attacking my brain severely. I did not think that I was going to be alive to see 2011. I contacted her.

I will refer to her as Jeanne S. I had to check her out to make sure that she was legitimate. Jeanne S. revealed credibility information that made me trust and believe her. I hired her. God have given her a precious “gift” as a “prophet”. She revealed to me the following, which I knew to be true:

- It was a group of people that put me and my family in this program (When she said the one of F.A.A. Manager came into the spirit. Her name echoes in my spirit. Was this a “personal vendetta” because of jealousy and racism? )
- People have always been jealous of me because of how I looked and how I carried myself and that I did have a jealous bone in my body;
- They were many “witches” in my neighborhood;
- They are trying to “age” me. Due to all of the trauma that I was experiencing my body went into early “pre-menopause”;
- She told me to keep up my appearance by dressing up as I have always done;
- She has never seen one person with so many implants;
- She never imagine meeting someone like me who loves Jesus and is truly Christ-like; and
- I love people and trust them, but many people have hurt me.

### **I asked her the question, “Why was this happening to me?”**

She responded, “They are doing it because they think that they can. Who is going to stop them?”

I asked her, “Who was doing this to me?” She replied, “The Federal Government.”

She agreed with my statement that this was not the entire Federal Government, but “unscrupulous Federal Government employees who are abusing their power.”

The arrogance of that statement caused something in my spirit to rise up and ask Jeanne S. to give the “unscrupulous Federal Government employees” a message: “Please tell me that I am going to stop them with the help of Jesus Christ/Yeshua.” It came out of my mouth before I knew what I had said.

Later, she revealed that they told her that “they were afraid of me”.

I thought to myself, “Why would these “unscrupulous Feds” be scared of me?”

Jeanne S. revealed to me that “I was going to help a lot of people”. She never told me whom, but I would figure it out later.

I was feeling and looking better. I was getting stronger each day.

**One day, Jeanne S. told me that these “unscrupulous Feds” offered her \$50,000.00, but she refused.** She stated that she had my back. Jeanne S. also told me that “Rick C. was paid a lot of money to no longer support me.” I replied her that Rick C. accepted \$25,000.00. She acted surprised that I knew the exact amount. It was the Holy Ghost who revealed it to me.

#### **About Rick C. & the weekend America’s Spiritual Revival Show**

Rick C. is a non-consensual “human subject” and a new follower of Jesus Christ. I did not think that he would turn on me, but he did. I confronted him, but he lied and I told him he is the reason why people are still going through this horrific ordeal. **He sold his soul for \$25,000.00.**

God was molding me and preparing me for years. Now, it was placed in my heart to start “America’s Spiritual Revival” on October 10, 2010. In preparing for this event on October 4, 2010, I faxed my handwritten letters to Pastors Donald McClurkin Jr. and Dr. Charles Stanley to request if they would develop the America’s Spiritual Revival Prayer. I contacted both Pastors’ offices and they stated that they did not receive my fax. I tried faxing, while I was on the phone with them, but they still did not receive it. As I was faxing the letters, the song “Marvelous” by the late Walter Hawkins was playing on the Gospel Music Choice Channel.

Unbeknownst to my parents, Verizon had turned off their long distance service. They were not late on their bill nor did they receive a notice or phone call from Verizon about this issue. My mother called Verizon and after several transfer calls (in order to get to the right “perp”), my mother was given the reason that someone made an International call and the person should not had been able to make the call with her calling plan. It had been about a week since I made a call to one of my International mold buddies who needed my support. I would have never imagined that a 1 hour call would cost me \$200.00. Like many of my “suspected” bills, I did not have time to fight or inquiry about it so I just went ahead and paid it anyway. I will deal with it later, like many of my issues that the “unscrupulous Feds” created for me.

Every weekend, I was hosting the Internet Talk Show for the “America’s Spiritual Revival”. Rick C. had agreed to do the internet portion of the show on TalkShoe because I did not have access to a computer. We had more people joining us each week. These unscrupulous Federal Government employees did not even want this revival to occur so that is why they offered him money to stop this revival from occurring in America, which he accepted. I was no longer able to host the shows anymore.

#### **People Paid a Total of \$125,000.00 in 2010 to Stop My Callings**

In early December 2010, I woke up from a dream and it was revealed to me that Jeanne S. had accepted \$100,000.00. **Jeanne S. sold her soul for \$100,000.** I thought that she was honest, but I did learn from that experience as well. I left her several messages, but she never called me back.

Later, I learned from Queen that Jeanne S. had told her that she was going to be free to help others in January.

I do not know if God took away her gift for what she did to me, but there will be justice. I told her that if I was that important, I would have held out for \$500,000.00 or even \$1,000,000.00, especially for her soul.

**At that moment, I realized that I was going to do something very important to advance God's Kingdom as well.**

I believe that Jeanne S. and Rick C. were paid with money that the "perps" stole from me over the years, but I could not provide it.

**(Note: I am a very meticulous and very organized person. Everything was organized in the vanilla folders inside the hanging colored folders by year. Over time, I noticed that entire folders were missing, or one item was left in the folder, revised/newly created items were left behind, or only the vanilla folder was left behind. Someone had been in my bedroom and in my Public Storage unit and done this. They left my Public Storage a mess, which the Federal Government agents or contractors did. Someone was interested in my financial records including bills, credit cards statements, monthly bank statements, and tax history to name a few. I thought it was odd at first. Over the years, I saw the same pattern with other family members. I no longer kept everything nice and organized so that they come in and take what they wanted. I tore off the names of the folders so that they would have to shuffle through all of them. They were stealing money, but I could not prove it. My credit score was pretty high. There was one item that was affecting me from having a "gold rating" again. I was trying to buy property, but they even caused my credit score to drop drastically. Recently, my hunch was confirmed by a "perp" who told me that **all "perps" steal money from the "human subjects". The "perps" are being taught by the Federal Government to conduct computer tampering so that there is no traceability. They are illegally STEALING or EMBEZZLING all of the human subjects' money.**)**

I was much stronger by December 2010. I was able to complete a letter to President Obama which I faxed from the public library, Congressman's Holt office, and even from Staples. I did not receive a response.

Two people were paid \$125,000.00. What a waste of Government resources when people need jobs and people are losing their homes because they did not receive a bailout package? Was this some of the money, which has been stolen from me over the years? I know for sure, but I want my money back with interest, according to God's plan.

My family and I are still ALIVE because of God's grace and mercy. I give Him all the praise and glory.

**This is how I came to know by accident that it was definitely the United States Federal Government in 2010.**

**What the "Unscrupulous Feds" Had to Do to Me Quickly?**

On January 16, 2013, I watched the movie, *Gaslight* (1940). I have never seen this version.

According to Wikipedia "Gaslighting is a form of psychological abuse in which false information is presented with the intent of making a victim doubt his or her own memory, perception and sanity. Instances may range simply from the denial by an abuser that previous abusive incidents ever occurred, up to the staging of bizarre events by the abuser with the intention of disorienting the victim. The term "gaslighting" comes from the play *Gas Light* and its film adaptations. The term is now also used in clinical and research literature. The term "gaslighting" has been used colloquially since at least the late 1970s to describe efforts to manipulate someone's sense of reality. In a 1980 book on child sex abuse, Florence Rush summarized George Cukor's 1944 film version of *Gas Light*, and writes, "even today the word [gaslight] is used to describe an attempt to destroy another's perception of reality". The term was further popularized in Victor Santoro's 1994 book *Gaslighting: How to Drive Your Enemies Crazy*, which outlines ostensibly legal tactics the reader might use to annoy others."

Throughout the movie, there were certain sentences, which resonated with me in my spirit. I could not shake it. I was able to find the entire movie on the internet to watch for free. Afterwards, my spirit became at ease after I wrote these words:

**"Quite by accident, I discovered their identities and now I have irrefutable proof of their existence. Now, I was considered dangerous to them. They have to slowly and methodically drive me out of my mind. They have to kill my mind. The unscrupulous Federal Government employees could not get rid of me by ordinary means for fear of an inquiry/investigation. They got to discredit me and fast. They know that I am not guilty of anything, except that I know the truth. They are not after the truth. They have to keep the lies and deception going. They will attempt to "break" me by utilizing various methods in order to make an impact. They will use any human weakness that I have to destroy me. In order to discredit anything that I was saying that was happening to me and my family, they have to**

**drive me crazy or get me declare as a “raving lunatic” by any means necessary, legally or illegally so that no one would believe me.”**

Many “non-consensual” human subjects are experiencing “gaslighting, myself included. Many people have stated that people were living in their “attic”. I did not think much of that until I noticed when I was downstairs playing Scrabble with my mother, I would come upstairs to find that a door was ajar, evidence missing, or he would like something to let me know that he was there.

### **War Levied Against Me Became Even More Malicious & Vicious**

My family & I were more than “non-consensual”, involuntary or “unwitting” human subjects. Were we declared as “targeted killings” now? We fit the definition, except, we are lawful and non-combatant. The Federal Government has engaged in levying an “INVISIBLE WAR” engaging “civilian military tactics” on us, but mostly me. I am now their “enemy”, even though I am lawful and non-combatant.

Since I am now a credible witness, I have been “deemed” an enemy, which I am not. I discovered their identities by accident and now I have irrefutable proof of their existence. They could not get rid of me by ordinary means for fear of an inquiry/investigation. They looked into my future so they are aware that I have been sent to stop them legally of course, while they continue their illegally methods against me with the countless of men, women, and children. They have intruded on giving out my personal and private information to those who did not need to know.

Since December 2010, their list of investigators, informants, moles, double agents, perpetrators (“perps” for short) or “researchers” against me has grown substantial. They have recruited many people from all walks of life in America and Internationally to participate in my demise. Now the emergency room physicians, psychiatrists, attorneys, city/state/county/Federal officials/representatives, business employees, police officers, neighbors, Facebook “friends, more neighbors and even more family members and friends could be considered as an accessory to **many crimes including “witness tampering”, obstruction of justice, fraud, attempted murder, retaliation against a victim, stealing evidence to conceal an investigation, or intentionally alters, destroys, simple battery by mingling substances (poisoning), mayhem, or conceals records or documents to impair the object’s integrity or availability for use in an official proceeding to name a few.**

**There are the more serious crimes of treason, domestic terrorism, genocide, crimes against humanity, war against peace, war crimes, war of aggression, violation of Natural Law, violation of the United States Constitution and Title 18. These crimes are also a concern for the International community. These are the same crimes that people were hanged for at the Nuremberg Trials. This is the reason why an International tribunal should be conducted.**

I have developed a Researcher/Investigator/Informant/“Perps” Opt-out Form for them to sign because they were tricked and deceived to do some “heinous” crimes. To date, no one has signed it. **God with his grace and mercy told me to extend this request to them until midnight PST/3:00 a.m. on August 9, 2013. I will not be happy if I do not receive ANY!**

They have used the technology against me and my family every day & everywhere. Here are five examples:

- I went blind “temporarily” due to spraying my vehicle with an unknown chemical that was penetrating my brain as I was driving. I was losing my sight. I saw halos around the light. I could not make out the distance of the vehicles. I pulled over & fell asleep in a hotel’s parking lot. I woke up and started to drive to the hospital. It was near. I saw a police’s car and waved him down. I told him that I was losing my vision and then it went completely black. He had oxygen in the car and my vision reappeared. I looked at my feet in the boots, which were extremely swollen. He called the ambulance and took me to the hospital, which was right down the street. Whoever sprayed the chemical or more likely a pesticide into the car sprayed a little too much. I could feel it burning my brain. It was penetrating my brain because my pores were opened and the chemical/pesticide lingered in the car.
- This “new” Dominican beautician was telling me that my hair was like her hair. After she put something in the “perm”, it turned my hair hard. She kept on insisting for me to go under the dryer, but I wanted my hair blow dry. I went to my cousin house afterwards to use the Internet. Someone was above me beaming my scalp. I had to get away from it. My cousin who I came to see fell asleep. My mother said that it did not look like I had a “perm” and she noticed small, red bumps in my scalp where I was being beamed. A couple of days later, I shampooed my long “good” hair and it was falling out in clumps. I was angry and crying because I was exposed to a lot of

radiation. My regular beautician came back from maturity leave and she had to cut all of my hair off down to a couple of inches. She stated that she never had to cut off my hair that short. I prayed to God that my hair would grow back and in 6 months, I had a shoulder-length "bob". I did not have a menstrual cycle for several months.

- The prophet, Jeanne S. had told me that they are trying to "age me". Due to the extreme trauma, my hair is turning gray. I have more gray hair than my mother and she is 21 years older. I have gained so much weight in a short amount of time. The torturing increased from September 2012 to the end of the end. Many other non-consensual, involuntary or "unwitting" human subjects stated the same. I never had to fight so hard for my life, as well as, others. In that short time, I have ballooned in size. I know that they are trying to destroy my looks. I know that I have an abundance of R.F.I.D. chips especially in my butt, stomach, and breast area. I have never been this big in my entire life. I saw one R.F.I.D. chip, the size of a penny that was along my wrist area. Before, I could show anyone it disappeared into my body. L.A. Murzulli states that Implants can change your DNA. He also stated that they should expel your body. I have done the test with the stud finder/sensor on my body and it beeps constantly, then I decided to do another test whenever I had a "bowel movement". Each and every time that I ran the stud finder/sensor over my "poop" it beeped. I was saving it, but someone was sabotaging my evidence.
- I decided to go out and pick-up some Chinese food. I went to a major food chain. I could feel the "energy" coming from the food. I told the manager that someone sprayed the food with someone to make me sick. The manager was very irate. I demanded my money. Less than a mile down the road, I pulled over. I felt something go through my body as I was making sure that I had everything. I was having convulsions, my heart rate, and blood pressure increased. I was afraid. I started praying. I was sweating profusely. I tried to get the health inspector to go there, but they would not. I file a police report. Even the police officer knew about "white women" following people in their vehicles. I filed a complaint on their website. This was P.F. Chang's

The very next day, I went to Applebee's and the same thing happened. I called the police and he took the report for my increased heart rate. He did not want to get the same tested. I was saving the food; 3 plates. I went to N.J. Governor's Office, Chris Christie to see if the food could be tested. It was radiation on the food. The State of New Jersey has a radiation dept., which I called, but to no avail. When I met with them, they were more concern about my evidence. One of the young man stated that they could take my evidence to the Attorney General and I stated let's all meet with the Attorney General, but they did not want to do that. Obviously, they knew what was going on. Later, I hand-delivered them a CEASE and DESIST letter, as well as, the Trenton's Mayor's office. "Someone from the Governor's Office called a Social Worker stating "I'm harassing the Governor by calling there ALL THE TIME so someone and that I looked homeless." This allegation came after I hand-delivered the CEASE and DESIST Letter.

I have ALWAYS BEEN ESCORTED from day 1 by a STATE POLICE and I have NEVER been upstairs to the Governor's Office. Two people from the Governor's office have always come downstairs to meet with me. I asked the Governor's office if this was a public building and why I am always being escorted to ensure that I am never seen in the Governor's office. Her response is that you have to follow the rules at the guard's desk. One police officer slipped and told me that I was a "troublemaker". When I asked him what I did? There was no response.

One day I went into the garage entrance to the State Building, which I have never done. Upon signing in, I notice a tag with my name on it, "Letitia Peters". I asked the police officer who were escorting me who is using my name or knew that I was coming here because I did not tell anyone. He stated that the guard from the front garage called & told them. There was no phone at the sign-in sheet. I asked the young lady when I left, if she called and she said no. It is rare that someone knows how to spell my first name. This is another irrefutable proof that I am being stalked, bullied, monitored and targeted.

One of my pet peeves is that I have no patience for LIARS and I have a low tolerance for racist people. It is uncalled for. In other words, I have a low tolerance for sin, just Jesus/Yeshua did. On June 30, 2013, I hand-delivered a 35 page Affidavit of Disclaimer to the Governor's office based on treason and seditious conspiracy because according to Title 18, If two or more people have ley war against you, delayed, hindered, or prevented laws from being enforced in the United States, then meant that definition. I sent information to President Obama

on June 21, 2013. He stated that he will review it and give it to the Attorney General. I intend to file an injury report for the State building and for the State of New Jersey Library.

I do not have any equipment to defend myself, because I am lawful, non-combatant. They have engaged in levying an “invisible” war against me and my family who is everything to her. **I want them to leave my family alone now.**

I have fought back with the use of the Power of God’s Word, Power of Fasting & Prayer, coupled with the Power of Love. I pray to the Creator/Yahweh through Jesus/Yeshua who I give all the praise & glory to for keeping me, her family and every non-consensual, involuntary, or “unwitting” human subject alive.

### **Research Provides Additional Irrefutable Evidence**

We have been “selected” (intentionally or randomly) to be a “non-consensual human subject” in a research/medical experiment. These medical experiments violate medical ethics. We have a name, which defines, what we are going through and others can understand. We are no different than the human subjects in the Tuskegee Syphilis Experiment or the Guatemala experiment, which was deemed last year as being “unethical”. This not only a moral issue, but for many, including myself, this also goes against our principles and beliefs. We are men and are entitled to nothing less than the full rights of every man. The acts of violence that have been taken against us should be condemned by all men who value freedom and justice.

We want freedom and justice. We want peace and not strife for the first time in years. We can request to “opt-out” of the non-consensual “human subject” and we can prove that the research/medical experiment does not comply with U.S. (Federal & State) & International Laws.

There is violation of U.S. civil and criminal laws, as well as, International law. We have the right to defend ourselves because it is our unalienable rights that cannot be infringed upon by anything. I am free to conduct my affairs however I see fit just so long as I do not infringe upon the rights of my neighbor, nor do I have the right to violate the Laws of God. I have been deprived of life, liberty or property without due process of law. Many “human subjects” think that we were selected because of retaliation or revenge.

We want our freedom NOW! My message is that the truth has to be revealed to the public. We want to spend time with our family, friends, and loved ones without being monitored, targeted, tortured, or tracked this summer.

This research has helped to prove my own case that my family and I were intentional selected “with the intent to retaliate against” me while I was still employed as a Federal employee in official duties (violation of Title 18) because toxic mold was creating unsafe and unhealthy work environment for me and others. I wanted reasonable accommodations and they would not provide it to me. Since fraud was committed, there is no statute of limitation.”

### **We Request to “Opt-Out” Now, which is the LAW!**

**Three generations of my family, which includes mature adults and children** have been *intentionally selected* to be a “participants” or “human subjects” in a research/experiment without our voluntary, informed consent, either orally or written and without our knowledge. **I already had** a compromised immune system due to the exposure of toxic molds/mycotoxins in the Federal buildings in Washington, DC. I was far from being that “healthy person with no major health ailments”, but I was working towards it every day so that I would have a better quality of life and become a productive U.S. citizen in the workplace and a pillar in the community once again. **I am on disability retirement & I would have never consented to be a “volunteer” in any research with all of my confirmed diagnoses; especially one which uses gamma rays, microwave, infrared and weapons (biological, chemical, directed energy, electronics & radiological).** In addition, the National Commission for the Protection of “human subject” believed that those who are already burdened (*e.g.*, by disabilities or institutionalization) should not be asked to accept the burdens of research unless other appropriate subjects cannot be found (*i.e.*, if the research concerns their particular disability or circumstance).

**My family and I have endured unnecessary & unimaginable pain and suffering that presents a danger to our well-being by continuing in this human research. We are in a life-threatening situation every day that we continue to be in this research. Furthermore, this violates our principles and beliefs.**

**I do not want any more delays. I believe that the delays have been so that I would succumb to the horrific atrocities that were being done to me. I had enough! We have ENOUGH!**

I woke up with terrible “eye pain”, migraine, and severe dry eyes. I fell asleep while conducting my blog talk radio show last night because the “energy” was really bad in my parent’s house last night when I left the library.

I want my life back so that I can enjoy the rest of the summer, go to the March of Washington event, get married and have children. I refuse to lose any more time out of my life. Is that so hard? About the lawsuits? You caused that on yourself. We demand full research/medical experiment disclosure.

You have not right in giving out our personal information to countless of people, without our permission.

Many “human subject” have contacted me to tell me how their “targeting” has increased. Many lives are at stake. We refuse to go into another month as a “secret”. The lies, secrecy, and deception can no longer continue.

### **Serious Crimes Have Been Committed Under the Guise of Research/National Security/War Against Terror; Warrant Immediate Attention**

**There are over 55,836+ Government-funded human subject research projects and that number is increasing yearly despite not having the laws to protect the well-being and safety of the “human subjects”. How are they getting their “human subjects”?** Since there are unable to get volunteers (i.e. torture 24/7 with radiation, go into an underground city to become their sex slaves with attractive people, or turn a heterosexual person into a gay person), the researchers are **intentionally selecting** to perform on “unwitting” or involuntary civilians, women, pregnant women, children, disabled, sick, mentally disabled, and the researchers often under the guise of "medical treatment", research, “national security”, “war on terror” on a large portion of poor, racial minorities, mentally ill patients or prisoners. As a result, many have become disabled, disfigured, deformed or died prematurely.

As a representative on behalf of countless of “involuntary or “unwitting” “human subjects” in America and International, the "researchers" are operating above the law and below the accepted standard of scientific, ethical, and humane research.

We are being exposed to research that have been condemned as unethical and illegal. They include deliberate infection with deadly or debilitating diseases, exposure to biological and chemical weapons, radiation, injection with toxic and radioactive chemicals, surgical experiments, interrogation/ torture experiments, tests involving mind-altering substances and a wide variety of others, which violates the laws and treaties mentioned in the Disclaimer Statements, as well as, research ethics and medical ethics.

**The top priority has been that the public or Government officials must never know the “whole truth” about the human subject research projects and/or medical experiments.**

They had determined that there must be no resolution ever for the involuntary or “unwitting” “human subjects”. No justice. No due process. No investigations. Once a “human subject” is identified as a “human subject”, they are one for LIFE. How is that possible? Donna Joy was transferred to about 8 to 10 research projects for the past 34 years because of a personal vendetta. This includes the family line, which makes this generational. The “human subject” can decide to change sides in order to stop the “torturing”, but they must never be able to leave the “secret organization”.

There has been poor oversight by all parties in the Federal Government and private sector in the past 15 years for the protection of “human subjects”. **Basically, nothing has been done to correct the problems identified since 1997 by Congress or the H.H.S. to protect the “human subject” in federally funded programs.** This includes the Biomedical professionals (investigators). They are morally responsible for their inaction to implement the policies, requirements, and laws.

**The “research institutions” (Dept. of Defense, Dept. of Justice, Dept. of Homeland Security, and Intelligence Agencies, International agencies and others) are unable to conduct a thorough and unbiased inquiry and investigation.** It would be another cover-up. This is what Edward Snowden knew.

This is why we are requesting a tribunal for the involuntary or “unwitting” human subject research survivors. Lies and deception have continued non-stop for 50 plus years. This started occurring before I was born. We, the human subjects have been faced with humiliation, persecution, committed to a mental institution, told that we are “delusional” or our evidence was infiltrated by “perps”. Thus this has resulted in years of fraud, cover-ups, no investigations, deaths, and

many of us received more “abuse” as punishment for seeking assistance to expose the truth. The “authority” of the Federal government has caused many police, sheriffs, government officials, and attorneys not to investigate because of “protocol” and thus we are left helpless. Many men’s lives have been destroyed and many deaths have resulted. These research projects and medical experiments have been done in secrecy. We were told that the public was never supposed to find out the truth, but we did and now we want justice and for the abuse to stop immediately. There has been waste, fraud, abuses of law and abuses of power. These people should be imprisoned for the rest of their lives.

For a crime to occur there must be an injured party (Corpus Delicti). The injured party can be injured: financially, physically, psychologically, and/or emotionally. As a result, the injured party can seek reliefs and/or remedies. **We are the injured parties, because crimes are occurring against the involuntary “human subjects”. There are many crimes that are being committed:**

i. Many of the 55,836+ research projects are violating The United States Constitution, which is the Supreme Law. **NSA, all agents, city/county/state & federal employees, city/county/ state/& federal officials, employees, officers, informers (in fact not presumption), contractors, sub-contractors, members, and representatives be informed of the Law of the Land (U.S. Constitution) and their obligation to enforce the Law and no longer be excused without action and to be made cognizance of the recompense of colorable actions on their part, by not adhering to the Law.**

- Involuntary or “unwitting” “human subjects have been called “slaves”, “prostitutes” and even said that the overall plan is to take all underground to become “sex slaves”. There are **lifetime**, generational involuntary or unwitting “human subjects” for the past 34, 40, or 50 years and then it becomes “generational. **How is that possible especially without their informed consent? Who are you to play god? Who determined and who considered unwitting “human subjects” as “unlawful combatants”? How can a child be one?**

Amendment XIII states **“Section 1. Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction. Section 2. Congress shall have power to enforce this article by appropriate legislation. “Could this be considered “slavery” or more specified “white slavery”? There has been one person every convicted and went to jail for that “white slavery”.**

- COINTELPRO activities has been deemed by the courts as unconstitutional. The involuntary or “unwitting” “human subjects” are experiencing overt and covert harassment by the “researchers/investigators/perps.
- Nonconsensual human experimentation is a violation of the Fourth, Fifth and Eighth Amendments of the U.S. Constitution. **(Note: Federal Government, Congress, HHS, and including International researchers have capitalized on this “loophole” since 1997. Congress have failed to ratify the law to close it. The Common Rule is being updated after 22 years, with its known deficiencies & “loopholes”.)**

**This is why we are calling for a moratorium on all Federal Government-funded 55,836+ human subject research projects/medical experiments in America and International.**

ii. An invisible, “secret” war has been levied against lawful, non-combatant citizens under the guise of research, medical treatment, national security, war on terror, or never-ending investigations. An “army of people” has been hired to harass, torture, monitor, track, target, maim, or drive people to suicide using electromagnetic radiation, chemicals, weapons (biological (mycotoxins), chemical, directed-energy, electronics, radiological) lasers, drones, satellites and implanting the “human subjects” with R.F.I.D. chips. They are to do anything within reason to “break them”: financially, emotionally, physically, and psychologically. This “army of people” have their own internal laws and regulations. **One researcher/perp stated that he should not say anymore or he would lose “sanctuary” and he confessed that he was being paid weekly by the Army.**

Everything is streamlined. They are good at deception and lies like the Germans. There was no plan for resolution ever for the unwilling or involuntary “human subjects”. No investigations. No due process. Laws are not being enforced. **“Civilian military activities”** have been engaged on the “human subjects”. A “secret”

Sec. 2381. Treason

Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States. **This is TREASON.**

Sec. 2382. Misprision of treason

Whoever, owing allegiance to the United States and having knowledge of the commission of any treason against them, conceals and does not, as soon as may be, disclose and make known the same to the President or to some judge of the United States, or to the governor or to some judge or justice of a particular State, is guilty of misprision of treason and shall be fined under this title or imprisoned not more than seven years, or both.

**Many people are guilty of “Misprision of TREASON”.**

Sec. 2384. Seditious conspiracy

If two or more persons in any State or Territory, or in any place subject to the jurisdiction of the United States, conspire to overthrow, put down, or to destroy by force the Government of the United States, or to levy war against them, or to oppose by force the authority thereof, or by force to prevent, hinder, or delay the execution of any law of the United States, or by force to seize, take, or possess any property of the United States contrary to the authority thereof, they shall each be fined under this title or imprisoned not more than twenty years, or both.

**Many people are guilty of Seditious Conspiracy.**

Two or more persons have prevented, hinder, or delay the execution of law in the U.S., which is “**Seditious Conspiracy**”.

According to Wikipedia, “**targeted killing** is the intentional killing, by a government or its agents, of a targeted person, whom they may consider an “unlawful combatant”, who is not in their custody. The target is a person who is allegedly taking part in an armed conflict or terrorism, whether by bearing arms or otherwise, who has allegedly lost the immunity from being targeted that he would otherwise have under the Third Geneva Convention.”

- iii. Many people have contacted the FBI and they have not done investigated the allegations. This is a deliberate, targeted assault on non-combatant American citizens and it is happening in the jurisdiction of the United States of America. **This is DOMESTIC TERRORISM.**
- iv. **The crimes of concern to the International community as a whole** are crimes against humanity, crime of genocide, war crimes & crimes against peace, crimes of aggression. These are the same crimes that the researchers were hung for “just doing their jobs” at the Nuremberg Trials. These are crimes against the peace and security of mankind. **We are demanding a tribunal to be held international with the United Nations Security Council because this is an International crisis.**

Since the NSA’S PRISM Research violates the United States Constitution, as well as, the laws listed in the Disclaimer Statements, the NSA’s PRISM, TETRA, PANDORA (CIA & ARMY), should be terminated and/or suspended immediately as well.

**We have the right to defend ourselves because it is a right that cannot be infringed upon by anyone or anything. The natural rights of life & liberty are unalienable; a gift from the Creator.**

**Everyone is entitled to Life, liberty and security of person, freedom from slavery and servitude, freedom from torture, or cruel, inhuman or degrading treatment or punishment, equality before the law, not being subjected to arbitrary arrest, detention, or exile, freedom of movement and residence, nationality, the right to marriage and to found a family, freedom of thought, conscience and religion, peaceful assembly and association, work, health, and education.
