"The Electors shall meet in their respective states and vote by ballot for President and Vice-President, one of whom, at least, shall not be an inhabitant of the same state with themselves; they shall name in their ballots the person voted for as President, and in distinct ballots the person voted for as Vice-President, and they shall make distinct lists of all persons voted for as President, and of all persons voted for as Vice-President, and of the number of votes for each, which lists they shall sign and certify, and transmit sealed to the seat of the government of the United States, directed to the President of the Senate; -- the President of the Senate shall, in the presence of the Senate and House of Representatives, open all the certificates and the votes shall then be counted; -- The person having the greatest number of votes for President, shall be the President, if such number be a majority of the whole number of Electors appointed; and if no person have such majority, then from the persons having the highest numbers not exceeding three on the list of those voted for as President, the House of Representatives shall choose immediately, by ballot, the President."

The US Constitution stated in Amendment XIV, ratified by the states in 1868:

"But when the right to vote at any election for the choice of electors for President and Vice President of the United States, Representatives in Congress, the Executive and Judicial officers of a State, or the members of the Legislature thereof, is denied to any of the male inhabitants of such State, being twenty-one years of age, and citizens of the United States, or in any way abridged, except for participation in rebellion, or other crime, the basis of representation therein shall be reduced in the proportion which the number of such male citizens shall bear to the whole number of male citizens twenty-one years of age in such State."

The US Constitution stated in Amendment XXVI, which was ratified by the states in 1971:

"Section 1. The right of citizens of the United States, who are eighteen years of age or older, to vote shall not be denied or abridged by the United States or by any State on account of age.
Section 2. The Congress shall have power to enforce this article by appropriate legislation."

As stated at <http://www.amnestyusa.org/research/reports/investigation-prosecution-remedy-accountability-for-human-rights-violations-in-the-war-on-terror?page=2>, **"The USA is required by international law to respect and ensure human rights, to thoroughly investigate every violation of those rights, and to bring perpetrators to justice, no matter their level of office or former level of office. Victims of human rights violations have the**

right under international law to effective access to remedy and reparation. In addition, there is a collective and individual right to the truth about violations. The United Nations, among others, has formally recognised "the importance of respecting and ensuring the right to the truth so as to contribute to ending impunity and to promote and protect human rights", referring in part to "the right of victims of gross violations of human rights and serious violations of international humanitarian law, and their families and society as a whole, to know the truth regarding such violations, to the fullest extent practicable, in particular, the identity of the perpetrators, the causes and facts of such violations, and the circumstances under which they occurred".

If the USA is to demonstrate that it is genuinely committed to human rights and the rule of law, Amnesty International considers that the new administration and Congress must ensure that truth and accountability are no longer buried under laws or policies that exploit or facilitate secrecy or impunity. Without "observance of the right to know and, by implication, the right to the truth, the right to justice and the right to reparation... there can be no effective remedy against the pernicious effects of impunity". As the independent non-governmental International Center for Transitional Justice has said, a holistic approach is necessary following a period of widespread human rights violations: "Without any truth-telling or reparation efforts, for example, punishing a small number of perpetrators can be viewed as a form of political revenge. Truth-telling, in isolation from efforts to punish abusers and to make institutional reforms, can be viewed as nothing more than words. Reparations that are not linked to prosecutions or truth-telling may be perceived as 'blood money' -- an attempt to buy the silence or acquiescence of victims. Similarly, reforming institutions without any attempt to satisfy victims' legitimate expectations of justice, truth and reparation, is not only ineffective from the standpoint of accountability, but unlikely to succeed in its own terms."

This document outlines the importance of immediately initiating effective independent criminal investigations, including into crimes under international law such as torture and enforced disappearance committed by individuals acting for or on behalf of the USA; removing potential obstacles in existing US law to successful investigation and prosecution of all such cases; and ultimately bringing perpetrators to justice. Any prosecutions must be conducted in independent and impartial courts applying international fair trial standards, without recourse to the death penalty."

These Federal agencies are doing whatever they want to do, because there's no accountability for misconduct or consequences for breaking the law. They have been hiding behind "security threat" or "national security", but it will not work this time especially, when they provided classified files to directors to make the film "Zero Dark 30". On December 21, 2006, Rees was stripped of her crown by the Miss Universe Organization with the approval of pageant co-owner [Donald Trump](#).”

“In United States law, good moral character describes behaviors in which the applicants have been involved and details requirements for consideration for certain benefits or positions. The term is chiefly used by the federal government in immigration law, but it can also be a requirement for a particular position of employment or licensure in a particular occupation or profession, such as admission to practice law and teaching. In order to gain U.S. citizenship through naturalization, a person must be considered of "good moral character".

It is the opposite of moral turpitude, another legal concept in the United States used in similar instances.

Moral turpitude is a legal concept in the United States and some other countries that refers to "conduct that is considered contrary to community standards of justice, honesty or good morals. [1] This term appears in U.S. immigration law beginning in the 19th century.[2]

The concept of "moral turpitude" might escape precise definition, but it has been described as an "act of baseness, vileness, or depravity in the private and social duties which a man owes to his fellowmen, or to society in general, contrary to the accepted and customary rule of right and duty between man and man." [3]

The classification of a crime or other conduct as constituting moral turpitude has significance in several areas of law. First, prior conviction of a crime of moral turpitude (or in some jurisdictions, "moral turpitude conduct", even without a conviction) is considered to have a bearing on the honesty of a witness and might be used for purposes of the impeachment of witnesses.[4] Second, offenses involving moral turpitude may be grounds to deny or revoke state professional licenses such as teaching credentials,[5] licenses to practice law,[6] or other licensed profession. Third, this concept is of great importance for immigration purposes in the United States, Canada (prior to 1976), and some other countries, since offenses which are defined as involving moral turpitude are considered bars to immigration into the U.S.[7] (https://en.wikipedia.org/wiki/Moral_turpitude)

In the Nov. 19th article, “**If You Voted for Trump Because of the Clinton Foundation, You Got Played**” states, “He claimed that Hillary was in public service for herself, and to just enrich herself. “<http://www.bluedotdaily.com/trumps-ties-to-russia-just-got-blown-wide-open-with-fbi-warrant/>, CPowell states, “According to that report, the FBI has issued a FISA warrant to investigate Trump’s private Russian email server, for national security purposes, now that he is president elect. ***“Two separate sources with links to the counter-intelligence community have confirmed to Heat Street that the FBI sought, and was granted, a FISA court warrant in October, giving counter-intelligence permission to examine the activities of ‘U.S. persons’ in Donald Trump’s campaign with ties to Russia.”***”

Continuing:

“The warrant covers any ‘US person’ connected to this investigation, and thus covers Donald Trump and at least three further men who have either formed part of his campaign or acted as his media surrogates. The warrant was sought, they say, because actionable intelligence on the matter provided by friendly foreign agencies could not properly be examined without a warrant by US intelligence as it involves ‘US Persons’ who come under the remit of the FBI and not the CIA. Should a counter-intelligence investigation lead to criminal prosecutions, sources say, the Justice Department is concerned that the chain of evidence have a basis in a clear warrant.”

According to Bipartisanreport.com:

During that investigation, it became clear that Donald Trump’s private Russian server was communicating with Alpha Bank, which seemed very fishy and highly coincidental. According to Heat Street, “the FISA warrant was allegedly granted in part because of the involvement of Vladimir Putin’s own daughters. One is married to a senior official at Gazprom, where Carter Page and Paul Manafort reportedly have holdings; another to Kirill Shamalov, a banking official.” A FISA warrant is a warrant that calls for an investigation into foreign intelligence affairs. This means that Donald Trump is being investigated specifically for criminal communications and direct ties to Russia and dictator, Vladimir Putin, whose advisor revealed after the election, that he had been in contact with Trump.

He was saying that Russia directly intervened in the US election to obtain a desired end: presumably to undermine confidence in US elections or to elect Donald Trump—or both. Rogers was clearly accusing Vladimir Putin of meddling with American democracy. This is news worthy of bold and large front-page headlines—and investigation. Presumably intelligence and law enforcement agencies are robustly probing the hacking of political targets attributed to Russia. But there is another inquiry that is necessary: a full-fledged congressional investigation that holds public hearings and releases its findings to the citizenry.

If the FBI, CIA, and other intelligence agencies are digging into the Russian effort to affect US politics, there is no guarantee that what they uncover will be shared with the public. Intelligence investigations often remain secret for the obvious reasons: they involve classified information. And law enforcement investigations—which focus on whether crimes have been committed—are supposed to remain secret until they produce indictments. (And then only information pertinent to the prosecution of a case is released, though the feds might have collected much more.) The investigative activities of these agencies are not designed for public enlightenment or assurance. That's the job of Congress.

When traumatic events and scandals that threaten the nation or its government have occurred—Pearl Harbor, Watergate, the Iran-contra affair, 9/11—Congress has conducted investigations and held hearings. The goal has been to unearth what went wrong and to allow the government and the public to evaluate their leaders and consider safeguards to prevent future calamities and misconduct. That is what is required now. If a foreign government has mucked about and undercut a presidential election, how can Americans be secure about the foundation of the nation and trust their own government? They need to know specifically what intervention occurred, what was investigated (and whether those investigations were conducted well), and what steps are being taken to prevent further intrusions.

There already is much smoke in the public realm: the hacking of the Democratic National Committee, the Democratic Congressional Campaign Committee, and John Podesta, the chairman of Hillary Clinton's campaign. Also, Russian hackers reportedly targeted state election systems in Arizona and Illinois. Coincidentally or not, the Russian deputy foreign minister said after the election that Russian government officials had conferred with

members of Trump's campaign squad. (A former senior counterintelligence officer for a Western service sent memos to the FBI claiming that he had found evidence of a Russian intelligence operation to coopt and cultivate Trump.) And the DNC found evidence suggesting its Washington headquarters had been bugged—but there was no indication of who was the culprit. In his recent book, *The Plot to Hack America*, national security expert Malcolm Nance wrote, "Russia has perfected political warfare by using cyber assets to personally attack and neutralize political opponents...At some point Russia apparently decided to apply these tactics against the United States and so American democracy itself was hacked."

Several House Democrats, led by Rep. Elijah Cummings, the ranking Democrat on the House Oversight Committee, have urged the FBI to investigate links between Trump's team and Russia, and Senate Minority Leader Harry Reid has done the same. According to various news reports, Russia-related probes have been started by the FBI targeting Americans associated with the Trump campaign. One reportedly was focused on Carter Page, a businessman whom the Trump campaign identified as a Trump adviser, and another was focused on Paul Manafort, who served for a time as Trump's campaign manager. (Page and Manafort have denied any wrongdoing; Manafort said no investigation was happening.)

Yet there is a huge difference between an FBI inquiry that proceeds behind the scenes (and that may or may not yield public information) and a full-blown congressional inquiry that includes open hearings and ends with a public report. So far, the only Capitol Hill legislator who has publicly called for such an endeavor is Sen. Lindsey Graham (R-S.C.). On Tuesday, Graham, who was harshly critical of Trump during the campaign, proposed that Congress hold hearings on "Russia's misadventures throughout the world," including the DNC hack. "Were they involved in cyberattacks that had a political component to it in our elections?" Graham said. He pushed Congress to find out.

The possibility that a foreign government covertly interfered with US elections to achieve a particular outcome is staggering and raises the most profound concerns about governance within the United States. An investigation into this matter should not be relegated to the secret corners of the FBI or the CIA. The public has the right to know if Putin or anyone else corrupted the political mechanisms of the nation. There already is reason to be suspicious. Without a thorough examination, there will be more cause to question American democracy."

 - how injuries have affected your life (such as work, sport or leisure activities)
 - any long-term impacts of injuries on your life
 - any ongoing medical treatment you need.
- Financially – financial loss of future earnings (if a physical or psychological injury has affected your ability to work)
 - general expenses caused.
 - cost of medical treatment needed.
- Socially - socially how have you and/or family been affected or will be affected?
 - work or study commitments
 - family or social life (friendships, social events, sporting commitments)
 - how safe or unsafe you and/or your family feel.

Michigan's 16 votes not apportioned because the race there is still too close to call. It would take overturning the results in both Wisconsin (10 Electoral College votes) and Pennsylvania (20 votes), in addition to winning Michigan's 16, for Clinton to win the Electoral College. There is also the complicating factor of "faithless electors," or members of the Electoral College who do not vote according to the popular vote in their states. At least six electoral voters have said they would not vote for Trump, despite the fact that he won their states.

The Clinton camp is running out of time to challenge the election. According to one of the activists, the deadline in Wisconsin to file for a recount is Friday; in Pennsylvania, it's Monday; and Michigan is next Wednesday. Whether Clinton will call for a recount remains unclear. The academics so far have only a circumstantial case that would require not just a recount but a forensic audit of voting machines.
