URGENT ACTION #2: Researcher Calls for Worldwide Opt-Out of Secret Human Subject Research & Request Hearing

In 1997, former Senator John Glenn said, “I want to put this in personal terms once again. You just think about your own family, your own son, your own daughter, or grandchildren who might be, the next time they go to a doctor, the subject of some medical experiment that they are not even told about. I do not think there can be many things more un-American than that. That is unconscionable, and we should not permit that.” The “Common Rule” has failed to protect the human subject since 1991 due to “loopholes”, which is a problem with many laws in America. There is no enforceable Federal regulation or International standard on the books for informed consent to be required because Congress has failed to ratify any proposed legislations pertaining to human subject protection in 1997, 2002, 2003, 2004, 2006, 2008, and 2011, thus allowing for unethical human subjects experiments to occur. Dr. Harriett A. Washington’s book, *Medical Apartheid* states in 1994, the Medical University of S.C. in Charleston was accused of enrolling poor African-American women into narcotic-treatment research without their knowledge. In 1995, an experimental measles vaccine was tested on mostly African-American & Hispanic children in L.A., without receiving their parents’ informed consent. From 1994-1995, N.Y.C. law enforcement officials helped researchers coerce African-American parents into enrolling their boys into a study that sought to establish a genetic propensity for violence, without receiving their parents’ informed consent. This scourge has spread beyond racial minorities, as detailed in her new book, *Deadly Monopolies*. Since the 1980s, 20 U.S. research projects have won legal waivers allowing them to bypass any form of informed consent. In 2011, drug giant Pfizer paid \$75 million to settle claims that children in Kano state, Nigeria, were injured or killed by non-consensual administration of its experimental meningitis drug Trovan.

Since Nov. 2010, I knew the truth that rogue U.S. Fed. Gov’t employees were abusing their power when Jeanne S. confirmed that my neighbors were trying to kill us. I asked her why? Her response was, “**They are doing this to you & your family because they can. Who is going to stop them?**” She told me that they were afraid of me because I was going to help a lot of people after she refused their initial offer of \$50k, but later accepted \$100k. Rick C. received \$25k to no longer co-host the America’s Spiritual Revival show, which began on 10/10/10. Now the enemy had to destroy me by any means legally/illegally. When the enemy cannot get its “target”, another person is selected who is close to the “target”, who is vulnerable like a child, sick friend, relative, or parents. This has been the case for Donnie McClurkin, Randy Quaid, Lindsey Lohan, etc. & myself.

I echo the words of Dr. Harriett A. Washington, author of *Medical Apartheid* and her new book “*Deadly Monopolies*” **Just as U.S. physicians demanded justice at Nuremberg, Nigerian parents stormed courts in Kano and Manhattan to demand that we live up to our stated ideals. Sixty-five years on, it is high time we did.” Don’t you agree?”**

The U.S. Common Rule is the only law that allows for waiver of informed consent. Children who are wards of the state should not be experimented on, but they can according to the U.S. Common Rule. **As of FY 2010, there were 55, 836 human subject research projects & that number is increasing even though the laws have not been ratified to close the “loopholes” in order to “protect” the welfare & safety of human subjects since 1997. Congress, researchers, & the Federal Gov’t are morally responsible for not holding the military, the intelligence agencies, & private industry accountable.**

Researchers’/Investigators are bound by a code of ethics that **includes the following protections for subjects and this includes everyone who are recruited the Key Student Personnel and Informants/Perpetrators:**

- **Protected from physical or psychological harm (including loss of dignity, loss of autonomy, and loss of self-esteem)**
- **Protection of privacy and confidentiality**
- **Protection against unjustifiable deception**
- **Parents/Guardians must give consent for minors to participate before interacting with the subject.**
- **Subjects have the right to refuse to participate without penalty if they wish.**

Experimenting on people in a research/medical experiment without their “informed consent” is universally recognized as a Law of Nations violation. Congress can constitute tribunals as stated in the United States Constitution. The U.S. Federal Government was created to protect and defend our unalienable rights – nothing else. The U.S. Federal Government is granted the power to prosecute 3 crimes – only

- Counterfeiting the current coins and securities of the United States
- To define and punish Piracies and Felonies committed on the High Seas

Offenses against the Law of Nations

An “Army of People” from ALL walks of life (police officers, physicians, private detectives, secretaries, media, delivery people, postal workers, neighborhood watch, agents, staffers, etc.) has LEVIED WAR & ENGAGED IN “CIVILIAN MILITARY ACTIVITIES” AGAINST LAWFUL, NON-COMBATANT MEN (and women), which meets the regulatory definition of **TREASON, UNDER THE GUISE OF RESEARCH/MEDICAL EXPERIMENT, NATIONAL SECURITY, WAR ON TERROR, WAR ON DRUGS** or NEVER-ENDING INVESTIGATIONS. They are told to “BREAK the MAN” and to “RUIN HIS (or her) LIFE”, which is a violation of research/medical ethics & U.S. & International Laws. Many of them are untrained to protect the well-being of the human subjects including the children and elderly, which violates medical & research ethics. This meets the definition of **DOMESTIC TERRORISM**.

Intelligence Agents have taught **Covert Entry** (bypass secured locks, doors, & security systems of vehicles, homes, & computers without showing any sign of forced entry) to civilians/criminals/informants, which is a violation of the law. Many business owners, CEOs, government officials, & church/synagogue leaders are unaware that their “**willing**” employees, customers, contractors, or members are utilizing their products, services and/or establishments to commit crimes or violate the rights of men. Police reports/events have been filed against P.F. Chang’s, Apple Bee’s, Best Buy, IHOP, & Shop-Rite, which substantiate that crimes are being committed. Crimes against humanity, genocide, & war against peace are being committed. The Germans were hanged for the same crimes at the Nuremberg Trials. THE PLAN HAS BEEN STAGED FOR NO RESOLUTION EVER FOR THE NON-CONSENSUAL, INVOLUNTARY OR UNWITTING “HUMAN SUBJECTS”. No justice. No due process. No investigations. **Lies, deception, active denial, disinformation, no oversight, lack of accountability, threats, bribery, blackmails, intimidation by force, abuse of power, protocol, the laws (“loopholes” were never closed)** and the technology have allowed this “well-oiled machine” to continue non-stop for 50+ years. In the article, *“Never too late: Nazi hunters tirelessly pursue 50 elderly Auschwitz war criminals”* states, “Recently, the Nazi Hunters have also been given fresh hope by a German court’s landmark ruling that has made it simpler to prosecute cases by opening the door to charges of “accessory to murder”. Bringing the perpetrators to justice sends an important educational and moral message to society at large: **These kinds of crimes will not be tolerated, and there are no free passes,” he said.** “Although unfortunately many of the perpetrators escaped justice, nevertheless each trial sends an important message.” **Are they still able to listen to every conversation with cipher keys & capacitors?**

Failure of OHRP to Investigate Allegations

On behalf of the Secretary, HHS, the Office on Human Research Protections (OHRP) approves the terms of these written institutional assurances, which constitute binding commitments. In essence, OHRP holds accountable and depends on institutional officials, committees, researchers, and other agents of the institution to comply with the institution’s assurance and the regulations. In carrying out its oversight responsibility, OHRP’s Division of Compliance Oversight monitors compliance through not-for-cause compliance oversight surveillance activities and for-cause compliance oversight evaluations of allegations or indications of noncompliance with the regulations. **OHRP has the authority under Title IV of the Public Health Service Act (42 USC 281 et seq.) to investigate complaints about human subject protections in HHS-conducted or -funded research, as well as any other research covered by the institution’s Assurance of Compliance.** OHRP also promotes compliance through its Division of Policy and Assurances, which provides policy and guidance documents pertaining to the regulatory requirements in 45 CFR 46. If HHS receives an allegation or indication of noncompliance related to human subject research that is conducted or supported solely by a Common Rule department/agency other than HHS, HHS will refer the matter to that department/agency for review and action as appropriate” as stated at <http://www.hhs.gov/ohrp/humansubjects/commonrule/>.

On April 26, 2011, I met with Kristina C. Borrer Ph.D., Division of Compliance Oversight Director to file a formal complaint and to find out which Federal agency was responsible for conducting non-consensual human experimentation on me and others. I was told by Ms. Borrer that there was nothing that her office could do for me and that I should contact each agency and file a FOIA request with each one. I knew there were a lot of research projects using human subjects and it would be like looking for a needle in a haystack. It would be very difficult, if not impossible to find, since there are more than 55,000 projects that involve human subjects. Others who contacted OHRP have received this response by letter, which states: “OHRP has determined that it does not have jurisdiction over the matters referenced in your letter. Therefore, OHRP will not be able to pursue this matter on your behalf.” Since January 15, 2009, all IRBs must use the Internet-based registration maintained by HHS as stated in 45 CFR 46.501. Is the answer right on HHS’s website? This presentation by Kristina Borrer addresses my concerns & nowhere does she mention FOIA at http://www.hhs.gov/ohrp/education/training/ded_webinar.html. I did not receive any feedback from anyone in HHS or OHRP pertaining to my complaint about NSA’s PRSIM & other human subject research projects, which is posted at <http://www.manifestthetruth.com/human-subjects-opt-out.html>.

Congress and HHS are sponsoring projects involving human subjects, without 45 CFR 46 being an enforceable lawfully, promulgated regulation, informed consent being on the books or a ratified Human Subjects Research Protection Law. As a result, “the absence of Federal jurisdiction over much privately funded research means that the **U.S. government cannot know how many Americans currently are subjects in experiments, cannot influence how they have been recruited, cannot ensure that research subjects know and understand the risks they are undertaking, and cannot ascertain whether they have been**

harmed.” Many involuntary or unwitting human subjects testified at the Bioethics Commission’s Meeting 4 Session 10 (March 1, 2011) and Meeting 5 Session 6 (May 18, 2011): Public Comments. There were others who submitted their written testimonies. The archived transcripts and videos are available at bioethics.gov/cms/meeting-four and bioethics.gov/cms/meeting-five. Several months later, the Office of Human Research Protections (OHRP) requested public comments pertaining to the update of 45 CFR 46 and has received 600+ pages of testimonies from human subjects and over 1100 responses, which did not include the public comments from the Bioethics Commission.

I couldn’t submit my Opt-Out form & 2 Affidavits (<http://www.manifestthetruth.com/affidavit-1-sent-to-the-us-aug-2013.html> & <http://www.manifestthetruth.com/affidavit-2-sent-to-the-us-nov-2013.html>), which were submitted on your behalf to the US nation’s leaders without Edward Snowden exposing the truth about NSA’s PRISM, which is **not** the only research violating our rights & should be terminated or suspended as per US & Inter’l laws. Since Nov. 2013, they defaulted & ignored my requests to opt-out & cease & desist. The U.S. & Inter’l laws states that we can **“opt-out of ANY research at any time without prejudice.”** They are ignoring my requests to opt-out, investigate, or arrest any of the perps. They include neighbors, family, saints, police, & doctors. I have been redlined. My evidence have been stolen, modified, & the rogue police have failed to investigate any of my crimes committed by my neighbors or at restaurants by filing police events & not police reports. **The rogue Feds can’t hide under national security, when they gave classified files for the movie Zero Dark Thirty.** The Federal Gov’t was created to protect & defend our inalienable rights which are being violated & to prosecute 3 crimes only, which includes offenses against the Law of Nations. Visit www.uglyjudge.com about exposing ugly judges, lawyers, police, & gov’t. Our bodies are made in the image of God & should not be used as research projects without our informed consent. This is a **desecration against God.** Ms. Peters states, “The late N.J. Sen. Frank Lautenberg was the only Congress rep to help me. May he R.I.P. We are enduring years of torture, persecution, illegal surveillances & obstruction of justice by fellow Americans, the FBI, military, police, & doctors, which is a felony; they can be charged with R.I.C.O. Act, human, civil, & constitution rights violations. I can prove beyond a reasonable doubt that we are undergoing abuses or violations under color of law. Crimes have occurred because we are the injured party (Corpus Delicti). FBF, informants, current & retired Feds/State/County/City employees/police, neighbors, friends, journalists, family members, doctors, businesses, etc. have until **12/31/15 @ 12:00 p.m. EST** to tell the truth by surrendering to the police/FBI or complete the form for leniency at <http://www.manifestthetruth.com/affidavit-for-researchersinformantsperps-form.html>. Experimenting on people without their informed consent is recognized as a Law of Nations violation & is a violation of the 4th, 5th, & 8th Amendments to the U.S. Constitution. The recent study called **“INVENTING TERRORISTS The Lawfare of Preemptive Prosecution”** depicts that the FBI is conducting racially charged persecutions & manifesting crimes by using **informants who are poor, criminals, & mentally challenged & offering incentives for their services such as cash & vehicles.** This study states that this is inhumane and unethical. Only 1% of terrorists are real.

If you know to do good & does not do it, it is sin (James 4:17). Do you know that you cannot do ANYTHING to any man to break them? They can be prosecuted for International laws for the rest of their lives.

As stated at <http://www.amnestyusa.org/research/reports/investigation-prosecution-remedy-accountability-for-human-rights-violations-in-the-war-on-terror?page=2>, “The USA is required by international law to respect and ensure human rights, to thoroughly investigate every violation of those rights, and to bring perpetrators to justice, no matter their level of office or former level of office. Victims of human rights violations have the right under international law to effective access to remedy and reparation. In addition, there is a collective and individual right to the truth about violations. The United Nations, among others, has formally recognised “the importance of respecting and ensuring the right to the truth so as to contribute to ending impunity and to promote and protect human rights”, referring in part to “the right of victims of gross violations of human rights and serious violations of international humanitarian law, and their families and society as a whole, to know the truth regarding such violations,

to the fullest extent practicable, in particular, the identity of the perpetrators, the causes and facts of such violations, and the circumstances under which they occurred".

They can see everything due to the implants in my eyes & hear everything due to implants in my body. The 12/16/15 published study confirms that cancer is avoidable if toxic chemicals & radiation are avoided, which are the main causes of most cancers (<http://www.theguardian.com/science/2015/dec/17/cases-cancer-avoidable-environment-lifestyle-disease>). I can prove that Donnie McClurkin & my parents diagnoses were caused by repeated exposure to toxic chemicals and/or radiation. Based on my exposure to chemicals & radiation, I developed tumors, which has grown, shrunk, & some even disappeared. This study confirms what my father's University of Pennsylvania oncologist told me 5 years ago when I asked him the question if my father's cancer could have been caused by the environment and he said yes. Pastor Donnie McClurkin has lost several family members to cancer. Pastor Donnie McClurkin would be sweating profusely while preaching at Perfecting Faith Church. He would not attribute his sickness to being exposed to radiation.
